Due to the number and type of resolutions differing in any given year, the information provided is based on one consistent resolution (being the reelection of Directors) as an example to highlight voting patterns over the period in question. Please note that the numbers will vary from resolution to resolution in any given year.

In the interests of transparency and completeness we have distinguished between the number of shares and the number of shareholders (represented by a shareholding) and provided voting patterns for each.

Note: The votes exercised by the Chair are in most instances when the Chair is appointed as proxy by the shareholder (all votes received in advance of the meeting appoint a proxy to vote on their behalf). Where the Chair has been appointed as proxy, we have included the numbers in the Chair column rather than the Proxy column. It is also worth noting that the Chair is required by law to vote the proxies granted to him/her. These proxies may be directed (i.e. the shareholder directs the Chair how to vote) or undirected, where the shareholder appoints the Chair as proxy and provides discretion to the Chair how to vote. In the latter case, both the Notice of Meeting and Proxy Form completed by the shareholder indicates how the Chair intends to vote those undirected proxies.
