In the period January 2019 to June 2020, per month:

- a. How many elective surgery procedures were covered, in each category (ie in Category 1-3 of elective surgery)?
- b. What was the amount of benefits paid out to policy holders for elective surgery procedures, in each category?
- c. How many claims were made for elective surgery procedures, in each category? [Insert written question as provided by the committee]

#### Answer:

Private health insurers do not hold claim data by surgical urgency category. Urgency category data is not required for the payment of private health insurance claims. In addition, historically private hospitals have not been required to utilise such a system.

We understand State and Territory governments have provided advice to private hospitals on managing elective surgery restrictions with in line with National Cabinet recommendations in an attempt to mirror surgical urgency categories, however, this data is not shared with health funds nor is it required for the purposes of paying hospital claims.

As a result, we are only able to provide data on the aggregate value and number of claims paid for the period requested. The data has been prepared on a date of service basis – this may not reflect all claims covered for the period due to delays in hospital billing cycles and payment timeframes. This data reflects *hospital admission costs only* and does not include medical costs that may be associated to each hospital episode.

For the period 1 January 2019 to 30 June 2020, benefits payable under our Overseas Visitor Covers and Private Health Insurance Covers are as follows:
