### **96.01** Opposition legislative amendments agreed to

In summing up the second reading cognate debate of the Social Security Legislation Amendment Bill 2011 and related bills, the Families, Community Services and Indigenous Affairs Minister indicated that the Opposition was going to move amendments on the Stronger Futures in the Northern Territory Bill 2011 which would be supported by the Government.

During consideration in detail of the Stronger Futures in the Northern Territory Bill 2011, an Opposition Member moved the detailed amendments, which were agreed to on the voices.

The Minister then moved two Government amendments and tabled a supplementary explanatory memorandum to the bill. The amendments were agreed to and the bill was read a third time.

### Private Members' business

96.12 Standing orders suspended—programming of private Members' business and committee and delegation business

On Monday 27 February the House agreed to a motion moved by the Leader of the House, by leave, to suspend standing and sessional orders. The motion provided for variations to the order of business and to the Selection Committee's determinations for the programming of private Members' business and committee and delegation business in the House that day, and in the Federation Chamber the following day.

The motion provided for a non-aligned Member to introduce a bill and for the Leader of the Opposition to move a private Member's motion in the Chamber during government business time that day.

The motion also suspended standing order 193 (Members' constituency statements) and arranged for the debate of private Members' business and committee and delegation reports in the Federation Chamber the following day.

The Leader of the House noted that this resolution allowed for the rescheduling of items of private Members' business and committee and delegation business which had been delayed due to the late meeting time that day (see entry 96.02).

### **96.14** Speaker's statement regarding relevance

On Wednesday 29 February, the Speaker made a statement to the House regarding the operation of the rule relating to relevance. He explained that in the conduct of debate, a Member must speak only to the subject matter of the question under discussion.

The Speaker noted some exceptions to the rule including the adjournment debate in both the House and the Federation Chamber, debate on the address-in-reply to the Governor-General's speech, debate on the budget bill and subsequent appropriation bills for the ordinary annual services of government, and the grievance debate.

The Speaker explained that if a Member moves an amendment to a motion including an amendment to the second reading of a bill, they and subsequent speakers, speak both to the original motion and the amendment.

He also noted that when the House debates bills cognately, a debate is permitted on the package of the bills generally.

The Speaker reminded Members that during debate on a motion to suspend standing and sessional orders, Members should confine their remarks to the reasons for the suspension and should not debate the substantive motion which is the subject of the suspension.

The statement was tabled by the Speaker.
