# 3.01 Passage of appropriation bills

On 11 September in the Federation Chamber, following the second reading of Appropriation Bill (No. 1) 2019, the Deputy Speaker made a statement regarding arrangements for the conduct of the consideration in detail of the bill. The Federation Chamber then proceeded to consider the bill in detail, in accordance with an agreed schedule for consideration of proposed expenditure for the various portfolios. The debate continued in the Federation Chamber over the sitting fortnight.

On 19 September, the Speaker reported to the House that Appropriation Bill (No. 1) 2019-2020, Appropriation Bill (No. 2) 2019-2020 and Appropriation (Parliamentary Departments) Bill (No. 1) 2019-2020 had been fully considered by the Federation Chamber and agreed without amendment. Consecutive motions for the third reading of each bill were agreed to without further debate.

#### Establishment of two joint select committees 3.06

On 10 September, a message from the Senate was reported informing the House that the Senate had resolved to establish a Joint Select Committee on oversight of the implementation of redress related recommendations of the Royal Commission into Institutional Responses to Child Sexual Abuse, including the establishment and operation of the Commonwealth Redress Scheme and ongoing support to survivors. The resolution required the committee to present its final report on the last sitting day of May 2022. The Assistant Minister to the Prime Minister and Cabinet moved that the resolution of the Senate be agreed to with amendments. The question was agreed to on the voices.

On 19 September, a message from the Senate was reported informing the House that the Senate had resolved to establish a Joint Select Committee on Australia's Family Law System. The Leader of the House moved that the resolution of the Senate be agreed to. The question was agreed to on division.

# 3.10 Opposition motion to suspend standing orders – Minister for Energy and Emissions Reduction

The Leader of the House moved that the Member no longer be heard, which was agreed to on division. The seconder and the next two speakers were also closured on division. The Leader of the House then moved that the question be put and the closure of question was agreed to on division.

Accordingly, the question on the suspension motion was put and negatived on division. Question time continued.

# 3.11 Two opposition motions to suspend standing orders – Member for Chisholm

After the acknowledgement of country and prayers on 12 September, the Deputy Manager of Opposition Business moved a suspension of standing orders without notice to allow him to move that the House, among other things, call on the Member for Chisholm to make a statement in the House responding to 'discrepancies in the Member's public statements this week'. Debate ensued and when the time allotted for the debate expired, the question was put and negatived on division.

On 16 September, the Deputy Manager of Opposition Business moved another suspension of standing orders without notice to allow him to move that the House note the Speaker's remarks regarding statements by Members (see entry 3.14), and calling on the Member for Chisholm to make a statement to the House. Debate ensued and the question that the motion be agreed to was put and negatived on division.

During question time on 12 September, the Deputy Manager of Opposition Business asked the Prime Minister a question regarding a media statement released by the Member for Chisholm (Ms Liu). In response, the Prime Minister tabled the media statement.

At the conclusion of question time, the Manager of Opposition Business noted that a deliberately misleading statement made by a Member in the House could be referred to the Privileges Committee as a matter of privilege and asked the Speaker whether there were forms available to the House if a statement tabled on behalf of another Member was found to be deliberately misleading.

The Speaker responded that a tabled statement was not a statement to the House and would not lead to an action before the Privileges Committee.
