As the first item of business on 15 October, the Member for Clark (Mr Wilkie) moved to suspend standing orders to allow him to move a motion which called on the Government to establish a Royal Commission to inquire into and report on the Australian casino industry.

Following debate, a division was called and deferred until after the discussion of the matter of public importance. The question that the motion be agreed to was negatived on division, with five Members on the side for the ayes.

In accordance with Standing Order 133, on Tuesdays, any division called for prior to 2 pm is deferred until after the discussion of the matter of public importance, except for a division called on a motion moved by a Minister during the period.

For the Chair to declare a question resolved without completing the count, fewer than five Members must be on one side (SO 127).

He noted that while some Speakers had taken a strict approach when ruling on questions containing taglines like 'alternative policies', he had been more liberal in his approach. However, he advised that, for a Minister's answer to be in order, he or she needs to address government policies within the answer and must not only address opposition policies.
