Bills

16.01 Bill introduced and passes all stages in one sitting

The Minister for Industrial Relations presented the Fair Work (Registered Organisations) Amendment (Withdrawal from Amalgamations) Bill 2020 on 9 December. After his second reading speech the minister sought, and was denied, leave for the debate to continue. He then, pursuant to contingent notice, moved that standing orders be suspended to allow resumption of debate on the second reading to be made an order of the day for a later hour. The question was carried, with only four minor party and independent members voting 'No'.

The bill was immediately called on and the second reading debate ensued. The Australian Greens member moved an amendment which called for further consideration of the bill to be deferred until the first sitting of 2021. The amendment was negatived and the bill was read a second time, with only two members voting against.

The minister then moved, pursuant to contingent notice, that standing orders be suspended to allow the motion for the third reading to be moved without delay. The question was carried and the bill was read a third time.

Under the standing orders, debate on a bill is usually adjourned to a future sitting following the minister's second reading speech.

16.02 Passage of bill relating to territory representation

On 7 December, the Electoral Amendment (Territory Representation) Bill 2020 was received from the Senate and read a first time. The bill amends the Commonwealth Electoral Act 1918 to change the method for determining the number of House of Representatives members for the Northern Territory and the Australian Capital Territory, one effect of which is to restore the Northern Territory to a two-member entitlement for the next general election. The Electoral Commissioner had in July issued a determination that provided for only one seat for the Northern Territory at the next election. On 9 December, a minister moved that

the bill be read a second time. After this was debated and agreed, by leave the third reading was also moved and agreed.
