Members

7.01 Member for Aston announces resignation

Prior to question time on 9 February the Member for Aston, by indulgence, announced his intention to resign from parliament the following week. The former minister reflected on his parliamentary career and thanked colleagues, friends and family. By indulgence, the Prime Minister and the Leader of the Opposition both thanked the member for his service.

The Speaker received the member's letter of resignation on 17 February. A writ will be issued for the election of a new Member for Aston on 27 February and the by-election will be held on Saturday, 1 April.

Parliamentary standards

7.02 Parliamentary Leadership Taskforce annual report

On 8 February the Speaker presented the Parliamentary Leadership Taskforce annual report for 2022. The report provided an update on the implementation of the recommendations of the Sex Discrimination Commissioner's *Set the Standard: Report on the Independent Review into Commonwealth Parliamentary Workplaces.* The Speaker made a statement in connection with the report, highlighting the ongoing work to promote safety and respect in Parliament House and other parliamentary workplaces.

7.03 Codes of conduct for parliamentarians, parliamentarians' staff and parliamentary workplaces

One of the recommendations of the *Set the Standard* report was that a joint committee be appointed to develop draft codes of conduct for parliamentarians, their staff and parliamentary workplaces. Accordingly, the Joint Select Committee on Parliamentary Standards was appointed towards the end of the 46th Parliament and again at the beginning of the current parliament. In its final report, presented in November last year, the committee proposed a behaviour code for parliamentarians, a behaviour code for parliamentarians' staff and behaviour standards for Commonwealth parliamentary workplaces.

On 8 February, the Prime Minister moved that the House endorse the codes and standards, pending the establishment of the advisory and enforcement regime, and final adoption. The motion was debated and then referred to the Federation Chamber. The next day, the motion was debated in the Federation Chamber, returned to the House and agreed to on the voices.

Privilege

7.04 Statement by Speaker on privilege matter

On the first day of the sitting fortnight, the Speaker made a statement in response to a privilege matter raised by the Leader of the Australian Greens on 1 December 2022 (see **6.04**). The matter concerned whether the Member for Cook had misled the House when, as Prime Minister, he had failed to disclose his appointment to multiple ministries.

In his statement, the Speaker referred to the report on the independent inquiry into the matter by Justice Virginia Bell AC and its finding that the actions of the former Prime Minister had not been consistent with the principle of responsible government and had undermined public confidence in government.

However, the Speaker advised that he did not see prima facie evidence that the Member for Cook had deliberately misled the House and therefore he could not grant precedence to a motion to refer the matter to the Committee of Privileges and Members' Interests. He added that the House had addressed the matter through its censure of the Member for Cook on 30 November last year (see **6.01**).

Motions

7.05 Condolence motion for Senator Jim Molan AO DSC

Also on 6 February, the Prime Minister moved a condolence motion in relation to the death, on 16 January, of Senator Andrew James (Jim) Molan, Senator for New South Wales from 2017 and former Major General. The motion acknowledged Senator Molan's long and meritorious public service and offered sympathy to his family in their bereavement. The Leader of the Opposition seconded the motion and all members present rose in silence as a mark of respect. The motion was then referred to the Federation Chamber for debate.

The motion was debated in the Federation Chamber on 8 February and was agreed to in the House the following day, with all members again rising in silence.

7.06 Delegated legislation

After the matter of public importance discussion on 7 February, the House agreed to suspend standing orders to allow for consideration of both a government motion to approve an instrument made under the *Migration Act 1958* and a private member's motion to disallow regulations made under the *Superannuation Industry (Supervision) Act 1993*. The suspension motion limited debate on each item to one hour.

Accordingly, the Minister for Home Affairs then moved that, under section 198AB of the *Migration Act 1959*, the House approve the instrument of designation of the Republic of Nauru as a regional processing country. The motion was debated and agreed to on division.

The Shadow Assistant Treasurer then moved the disallowance motion standing in his name—That the Superannuation Industry (Supervision) Amendment (Annual Members' Meetings Notices) Regulations 2022 made under the *Superannuation Industry (Supervision) Act 1993* be disallowed and debate ensued. The question on the disallowance motion was put, a division was called, and the division was deferred in accordance with standing order 133. The motion was disagreed to the next morning.

Statements

7.07 Ministerial statements

On Thursday, 9 February, the Minister for Defence made a ministerial statement relating to securing Australia's sovereignty. The shadow minister then addressed the House in reply. On Monday the following week, the Leader of the House presented a copy of the minister's statement and moved that the House take note of the document. The take note motion was referred to the Federation Chamber, where it was debated the following day.

On 13 February, the Prime Minister made a ministerial statement on the 15th anniversary of the national apology to Australia's Indigenous Peoples and the Closing the Gap Implementation Plan. He then presented a copy of his statement and of the Closing the Gap Implementation Plan 2023. The Leader of the Opposition addressed the House in reply.

The Leader of the House then moved that the House take note of the Prime Minister's statement and debate ensued. The Minister for Indigenous Australians and the shadow minister both spoke before the motion was referred to the Federation Chamber for further debate. The motion was debated in the Federation Chamber over the week.
