## **Committees**

#### 11.01 Presentation of the Voice referendum committee report

On Monday, 22 May, the Joint Select Committee on the Aboriginal and Torres Strait Islander Voice Referendum presented its advisory report to the House. The report was presented by the Deputy Chair of the committee, the Chair being a senator.

The advisory report recommended that the Constitution Alteration (Aboriginal and Torres Strait Islander Voice) 2023 be passed unamended.

# Bills and other legislative proposals

# 11.02 Passage of the Constitution Alteration

On Monday, 22 May, the Leader of the House, by indulgence, provided information about how debate for the Constitution Alteration (Aboriginal and Torres Strait Islander Voice) 2023 would proceed over the fortnight. He outlined that it would not be referred to the Federation Chamber, that the third reading vote would not happen until the next week, and that a division would automatically occur at the third reading to record whether an absolute majority was reached. Following the presentation of the Joint Select Committee's advisory report later that day, the House resumed debate on the legislation.

On Tuesday, 30 May, standing orders were suspended to allow the House to continue sitting until all members who wished to speak had done so, with provision for the half hour adjournment debate to still occur at 7.30pm. Debate on the second reading concluded at 8.03pm, after the adjournment debate. In total, 118 members spoke during the second reading debate on the legislation.

On Wednesday, 31 May, the question was put on the second reading and carried on division. An opposition member moved two detail amendments together, by leave, and these were defeated on the voices. The House divided on the question that the bill be agreed to, which was carried, and the Attorney-General, by leave, moved the third reading immediately. The question was carried on division (121 Ayes:25 Noes) with the absolute majority required under section 128 of the Constitution.

If the Constitution Alteration passes both Houses, it may be put to voters at a referendum not less than two months and not more than six months after its passage.

Under the Referendum (Machinery Provisions) Act 1984, members of Parliament authorise statements for and against a proposed constitutional alteration to be included in a 'Yes/No Case Pamphlet' for distribution to voters. Only those who voted for the proposed law may contribute to the 'for' argument and only those who voted against to the 'against' argument.

### 11.03 Appropriation bills

Also on Monday, 22 May, the House agreed to a debate management motion relating to the 2023-2024 appropriation bills. Under this motion, the appropriation bills were referred to the Federation Chamber for debate and will return to the House after prayers on 13 June. The resolution also set the order and timings for consideration of portfolios during consideration in detail in the Federation Chamber.

### 11.04 Customs Tariff Proposal

On Thursday, 25 May, the Minister for Home Affairs and Minister for Cyber Security moved Customs Tariff Proposal (No. 1) 2023. This tariff proposal amends the description of goods eligible for the customs duty concession, retrospectively from 1 December 2022, to allow the European Space Agency to import goods for its activities in Australia free from customs duty.

By convention, duties can be collected from the day a tariff proposal is moved, even though the motion has not been agreed.

### 11.05 Unresolved questions from the Federation Chamber

Several bills were returned from the Federation Chamber to the House with unresolved questions, including:

- Infrastructure Australia Amendment (Independent Review) Bill 2023, with one unresolved question
- Fair Work Legislation Amendment (Protecting Worker Entitlements) Bill 2023, with six unresolved questions
- Migration Amendment (Giving Documents and Other Measures) Bill 2023, with one unresolved question and
- Inspector-General of Live Animal Exports Amendment (Animal Welfare) Bill 2023, with one unresolved question.

Divisions cannot occur in the Federation Chamber and if a question cannot be decided on the voices it is reported to the House for later resolution there. An unresolved question arises when any Member dissents from the result announced from the Chair.

### 11.07 Chair of Economics Committee raises a matter of privilege

On Tuesday, 30 May, the Chair of the Standing Committee on Economics raised a matter of privilege with the Speaker. He raised concerns that two media articles had been published which contained information provided to the committee in a private briefing and undertook to investigate the apparent breach and report back to the House.

On Thursday, 1 June, he informed the House that the committee had found that the unauthorised disclosure was unlikely to have caused substantial interference to the work of the committee such as to amount to a potential contempt. He also noted that it would be difficult to determine with any certainty the source of the disclosure.

Under the standing orders and the Parliamentary Privileges Act, the unauthorised disclosure of committee documents and any proceedings is prohibited.

Members rose in respect to mark the death of several notable persons during the period:

- on Monday, 22 May, the Prime Minister moved a condolence motion regarding the death of the Hon Tony Staley AO, former minister and member for Chisholm from 1970 to 1980
- on Thursday, 25 May, the Prime Minister and Leader of the Opposition made statements by indulgence on the death of Mr Frank McGovern OAM, the last remaining survivor of the HMAS Perth and
- on Wednesday, 31 May, the Speaker informed the House of the death of Bruce Childs, senator for New South Wales from 1981 to 1997.

Also on 22 May, three condolence motions (for Hon John Kerin AO, Hon Stewart West and Yunypingu AM) were returned from the Federation Chamber and were immediately considered together. A single question was put on the three motions moved by the Prime Minister and agreed to, with members rising in their places.

Condolence motions are usually moved following the death of a Governor-General, a sitting member or senator, or former members or senators who held certain offices. From time to time, condolence motions may also be moved following the death of a distinguished Australian or a foreign Head of State or Government. In most circumstances, the death of a former senator or member, or of a notable Australian, is marked with a statement by the Speaker without a motion being moved.
