# Speaker

### 13.01 Statement by Speaker – Changes to division procedures

On Tuesday, 1 August, the Speaker informed the House that procedures for stating a question for decision would revert to standard form as provided in the standing orders: 'that the [proposal] be agreed to'. Members would still be required to vote 'aye' or 'no' on the voices to a question before the House, but the reversion would mean that many members might need to cross the floor to the other side of the Chamber when voting in divisions.

The Speaker noted that this reversion to usual practice would not be familiar to members, especially those who had taken their places in the 47<sup>th</sup> Parliament.

Since 2020, as a COVID-19 precaution to minimise movement in the Chamber, the question had been put as either 'that the [proposal] be agreed to' or 'that the [proposal] be disagreed to' in order to limit the requirement for members to cross the floor.

#### 13.02 Consideration of member's remarks

On Wednesday, 9 August, during the matter of public importance, the Member for Griffith made remarks which offended members present. When asked by the Deputy Speaker to withdraw following multiple points of order by members present, the member refused to do so. He was then told by the Deputy Speaker to resume his seat. The matter was reported to the Speaker for consideration.

Later, after discussing the matter with the Member for Griffith, the Speaker explained the incident to the House and gave the call to the member, who then withdrew his comments.

## Bills

#### 13.03 Amendment to proposed second reading amendment lapses

On Tuesday, 8 August, during the second reading debate on the Treasury Laws Amendment (Making Multinationals Pay Their Fair Share—Integrity and Transparency) Bill 2023, a crossbench member proposed an amendment to an opposition amendment moved in an earlier sitting. There being no seconder, the crossbench member's amendment to the amendment lapsed and debate returned to the question on the opposition amendment.

## 13.04 Parliamentary workplace bills

On Thursday, 10 August, three bills were introduced giving effect to recommendations of the Australian Human Rights Commission's *Set the Standard: Report on the Independent Review into Commonwealth Parliamentary Workplaces:* 

- the Parliamentary Workplace Support Service Bill 2023 and a related bill, seeking to establish a statutory Parliamentary Workplace Support Service providing human resources services for parliamentarians and persons employed under the *Members of Parliament (Staff) Act 1984* and other services to support positive cultural change across Commonwealth parliamentary workplaces and
- the Members of Parliament (Staff) Amendment Bill 2023, intended to modernise and clarify the employment framework for parliamentarians and their staff.

Debate on each of these bills was adjourned after the Minister's second reading speech and resumption of the debate made an order of the day for the next sitting.

Committees

## 13.05 Procedure Committee tables report

On Monday, 7 August, the Standing Committee on Procedure tabled its report *Raising the Standard*, concluding its inquiry into recommendations 10 and 27 of *Set the Standard: Report on the Independent Review into Commonwealth Parliamentary Workplaces*.

The committee recommended amendments to the standing orders in relation to offensive language and sanctions against disorderly conduct, as well as other guidance and supports for members, with the aim of improving safety, respect and inclusiveness in the House of Representatives. The Chair and Deputy Chair each made statements in relation to the report. Debate was then adjourned, and resumption of debate referred to the Federation Chamber.

## 13.06 Referral to Economics Committee

Also on 7 August, the Assistant Treasurer moved, pursuant to notice, that the House refer matters relating to insurers' responses to recent natural disasters in Australia to the Standing Committee on Economics for inquiry and report by 30 September 2024. Debate ensued and the question was carried on the voices.

Standing order 215(b) provides that general purpose standing committees may inquire into and report on matters referred by either the House or a Minister. It is not common for the House to refer inquiries, with most being received from Ministers.

#### 13.07 New member sworn

On the first day of sittings, Monday, 31 July, the Speaker announced that, following the return to the writ for a by-election in the division of Fadden, Mr Cameron Caldwell had been elected. Mr Caldwell was admitted to the Chamber where he made and subscribed the affirmation of allegiance required by law.

#### 13.08 Leave of absence

On Monday, 31 July, the Member for Brisbane moved that leave of absence be granted to the Leader of the Australian Greens for the current period of sittings for personal reasons. The question was carried.

# Motions

#### 13.09 Condolence motion

On 31 July, the Prime Minister moved a condolence motion on the death of the Hon Simon Findlay Crean, Member for Hotham from 1990 to 2013 and a former Minister and Leader of the Australian Labor Party. The Leader of the Opposition seconded the motion, and the Minister for Home Affairs and Minister for Cybersecurity (the current Member for Hotham) and the Leader of the Nationals also made contributions to the debate.

Members then rose in their places as a mark of respect. Debate was adjourned and the motion referred to the Federation Chamber, where it was debated throughout the sitting fortnight.

#### 13.10 Opposition motion to suspend standing orders

During Question Time on 3 August, the Leader of the Opposition sought leave to move a motion relating to the proposed Voice to Parliament. Leave was not granted, so the Leader of the Opposition then moved to suspend standing orders to enable him to move the motion. The motion to suspend standing orders was debated and defeated on division.

### 13.11 Private member's motion lapses

During private members' business on Monday, 7 August, a private member's notice relating to COVID-19 vaccinations was called on and, as the member was not present for the call, the notice lapsed and was removed from the notice paper.

A motion not moved when called on is removed from the notice paper unless the member who gave notice, or another member at their request, has moved its postponement.

### 13.12 Minister's motion on Robodebt Scheme

On 10 August, the Minister for Government Services, pursuant to notice, moved a motion that the House accept the findings of the report of the Royal Commission into the Robodebt Scheme. In the ensuing debate, an amendment to the motion was moved by the Manager of Opposition Business and was defeated on division. The original motion was then agreed to on division.

# Questions

### 13.13 Question without notice to Committee Chair

During Question Time on Thursday, 3 August, the Member for Jagajaga asked a question to the Member for Bruce in his capacity as Chair of the Joint Committee of Public Accounts and Audit, seeking information in relation to the committee's current inquiry into procurement at Services Australia and the National Disability Insurance Agency. The Member for Bruce provided a response informing the House of the inquiry processes to date.

It is rare for questions without notice to be directed to members other than Ministers. In accordance with standing order 99, other members may be asked questions without notice relating to a bill, motion, or other business of the House or a committee for which the member is responsible. Such questions are ordinarily confined to matters of timing or procedure.

# Statements

### 13.14 Statements by indulgence of the Chair

On 31 July, during the time for Government Business, the Member for Cook made a statement by indulgence relating to the report on the Royal Commission into the Robodebt Scheme and his role in the scheme.

On 10 August, prior to Question Time, the Prime Minister made a statement by indulgence informing the House that he had accepted an invitation from President Joe Biden to

undertake an official visit of the United States. The Deputy Leader of the Opposition, also by indulgence, supported the Prime Minister's remarks.

During the sitting fortnight, indulgence was granted on several occasions for statements relating to women's sport:

- On 1 August, following Question Time, the Prime Minister recognised the recent successes of the Australian women's soccer and netball teams the Matildas and the Diamonds, respectively. The Leader of the Opposition supported the Prime Minister's remarks, also acknowledging the work of the Australian women's cricket team in the recent Women's Ashes series.
- On 3 August, prior to the Matter of Public Importance, the Prime Minister informed the House that he had written to the Presiding Officers asking that Parliament House be illuminated in green and gold on the following Sunday and Monday nights in honour of the Matildas' next match in the FIFA Women's World Cup. The Speaker thanked the Prime Minister and informed the house that this request had been approved.
- On 7 August, prior to Question Time, the Prime Minister congratulated the Diamonds on winning the Netball World Cup. Later, both the Prime Minister and Leader of the Opposition rose to associate themselves with the answer to a question to Minister for Sport about the impact of the women's netball and football competitions on sport in Australia.
- On 8 August, prior to Question Time, the Prime Minister rose to congratulate the Matildas on their win the previous night and thanked the Speaker for illuminating Parliament House in green and gold. The Leader of the Opposition joined the Prime Minister in his congratulations.
