

# Senate Legal and Constitutional Affairs Legislation Committee Additional Estimates 2023–24 Monday, 12 February 2024 Daily summary

The committee met from 9.00am until 10.59pm.

#### The committee called the:

Department of Home Affairs (Incl. Australian Boarder Force) for cross-portfolio, corporate, and general matters; Outcome 1; Outcome 2; and Outcome 3; National Emergency Management Agency; Australian Security Intelligence Organisation; Office of the Special Investigator; Office of the Inspector-General of Intelligence and Security; and Commonwealth Director of Public Prosecutions.

Topics discussed by the committee included:

Department of Home Affairs – Cross-portfolio, corporate, and general matters

- Advice provided to government regarding High Court decision in NZYQ v Minister for Immigration, Citizenship and Multicultural Affairs & Anor;
- Acting arrangements within Senior Executive Service level of the Department of Home Affairs; and
- Review of Integrity Concerns and Governance Arrangements for the Management of Regional Processing Administration by the Department of Home Affairs by Mr Dennis Richardson AC, 12 February 2024.

#### Department of Home Affairs - Outcome 1
