

Senate Environment and Communications Legislation Committee Additional Estimates 2023-24 Tuesday, 13 February 2024 Daily summary

The committee met from 9.00am until 9.09pm.

The following agencies appeared before the committee: Department of Infrastructure, Transport, Regional Development, Communications, and the Arts (Corporate matters and outcome 5.1), Australian Broadcasting Corporation, Australian Communications and Media Authority; Australian Postal Corporation; Office of the eSafety Commissioner; NBN Co Limited; Classification Board; Creative Australia.

The following matters were discussed:

DITRDCA – Corporate
