

Senate Community Affairs Legislation Committee Additional Estimates 2023-24 Thursday, 15 February 2024 Daily summary

The committee met from 9.00am until 10.53pm in Committee Room 2S1.

Department of Health and Aged Care (DoHAC) - Whole of Portfolio / Corporate Matters

- Average Staffing Levels;
- Increases to the number of mental health care workers under the Better Access Initiative;
- Update of external reviews commissioned by the Minister of Health and Aged Care;
- Reproductive healthcare, including funding for various maternity and reproductive services;
- Impact of the 'Right to disconnect' legislation;
- Appointments of former senior departmental officials;
- Vyvanse shortages;
- Status of government responses to the Community Affairs References Committee inquiry into ADHD and the Senate Select Committee Inquiry into Dental Services;
- Indemnity insurance for midwives and MBS taskforce recommendations on midwifery;
- Guidance on vaccine mandates, including batch testing of covid vaccines; and
- National COVID-19 Clinical Network Taskforce.
