Supplementary information about the disposal of billiard tables, and items with possible heritage value

Billiard tables—On 15 August 2011, Mr David Kenny, Acting Secretary of DPS sent you a copy of the internal audit report by PricewaterhouseCoopers (PwC) into the disposal of two billiard tables from the former staff recreation room.

Amongst other matters the PwC report noted that DPS had also asked PwC to undertake a valuation and assessment of the age of the billiard tables. The valuation and assessment is now complete, and a copy is attached to this letter for consideration by the Committee.

2 Items with possible heritage value—On 4 July 2011, I wrote to Senator Polley in her role as Chair of the Committee, providing advice about a range of issues related to the May 2011 Budget Estimates hearings. One of the actions which I noted in that letter was the commencement of a preliminary survey of items under the control of DPS in and around Parliament House with possible heritage and cultural values.

The intent of this survey has been to identify items, that may have heritage and cultural values, which are "additional" to the items and assets already formally recorded in accordance with the definition of heritage and cultural items provided in the Orders of the Minister for Finance and Deregulation.

The preliminary survey has been undertaken by senior and experienced officers of DPS, and I now forward a copy to you for possible consideration by the Committee. I note that it is the intention of DPS to implement the recommendations at the front of the survey report.

Before I conclude, I also note that the review of DPS disposal practices (which was also foreshadowed in the letter of 4 July 2011) is now well advanced. Once it is completed, we will also forward a copy of that review to the Committee.

1 Executive summary

1.1 Overview

PricewaterhouseCoopers (PwC) has been engaged by the Department of Parliamentary Services (DPS) to provide a valuation of billiard tables (tables) located in Parliament House.

The review follows the Internal Audit Review of the Disposal of Equipment from the Staff Recreation Room which recommended that DPS obtain a valuation of two tables sold in 2010 and the remaining two tables located in the House of Representatives Alcove at Parliament House. The Internal Audit has been completed as part of the Internal Audit contract between Pricewaterhouse Coopers and DPS.

1.2 Internal Audit objectives

The objective of this review was to provide DPS with information in respect of the value of two tables sold in 2010, and the remaining two tables located in the House of Representatives Alcove. Specifically DPS has requested that we determine the origin, age and value of the tables.

We have sought expert opinion from three sources to determine the current market value of the tables as follows:

- Market Value, without reference to any provenance associated with being located in either Old Parliament House or New Parliament House.
- Market Value with the provenance, if any, associated with being located in either Old Parliament House or New Parliament House.

1.3 Summary of findings

From our Internal Audit we have found the following information in relation to the origin, age and value of the tables

Detailed findings are presented below:

1.4 Detailed findings

Valuation of the two Billiard Tables sold by DPS in 2010 and previously located in the Staff Recreation Room

- The Internal Audit Review of the Disposal of Equipment from the Staff Recreation Room noted that the tables located in the staff recreation room were purchased new in 1989.
- Heiron & Smith Australia have reviewed photographs of the tables and confirmed that they are a turned leg "Australia" model manufactured in 1988 by Heiron & Smith.
- Heiron & Smith estimated that the value on the open market of each table would be between \$1,500-3,000.
- Pickles Valuation Services (Pickles) are of the opinion, based on the evidence that the tables were purchased in 1989 that the \$2,500 received for each table by auction is in line with the market estimates for this type of asset.
- Pickles has noted that the replacement costs for similar tables from the same supplier are quoted from \$10,000.
- In Pickles opinion, the tables have no real heritage weighting to them due to their homogeneous character, age, and as they seem to be of a standard stock.

Valuation of the two Billiard Tables located in the House of Representative Alcove

- The Internal Audit Review of the Disposal of Equipment from the Staff Recreation Room noted that the
 tables located in the House of Representative Alcove were transferred from Old Parliament House in 1989 by
 the Parliament House Construction Authority, and re-furbished at that time.
- No records have been found which indicate the actual age of the two billiard tables, however both Pickles
 and Alcocks have indicated the age of tables is likely to be in excess of 50 years.
- Neither Heiron & Smith nor Alcocks were able to provide a potential value on the tables as they were unable
 to determine the makers name or style.
- Pickles were of the opinion they that the tables are of the style of Old Parliament House in the design style
 "Stripped Classical Style" of John Smith Murdoch (Canberra's first Government architect). This is an opinion
 on the style only, they have recommended a heritage expert to confirm the age as to determine if they were
 conceptual original pieces or commissioned in the style of Old Parliament House design at a later date.
- Pickles Valuation Services opinion is the estimated Fair Value of these tables to be in the vicinity of \$10,000 each. It should be noted that this estimate of value was formed by applying a heritage weighting or celebrity ownership value.
- Pickles have noted that the replacement costs for similar tables are likely to be in excess of \$12,000.

2 The Internal Audit

2.1 Scope

We have obtained independent expert advice in relation to the valuation of the tables from the following sources:

- Heiron & Smith
- Alcocks Billiards
- Pickles Auctions

The advice received from the above companies has been attached at Ap

The report has been provided for the intended sole use of DPS management. Any assurance provided in relation to the subject matter of review is for DPS management who are responsible for the subject matter. 2.2 Approach

The key features of our approach to address the objectives were to:

- Determine the most appropriate experts, from outside PwC, to provide advice on the value of the tables and engage them.
- Analyse and review evidence obtained.
- Preparation of a draft discussion paper and consultation with DPS stakeholders in the form of an exit meeting.
- Distribution of the draft report to relevant stakeholders within DPS for formal management comment.
- · Release of the final report.

It was a great pleasure meeting yourself and Noel personally in an attempt to gather more precise information about the two previously unidentified full-size hilliard tables located at Parliament House.

Regrettably, my personal inspection did not lead to concrete conclusions of any importance. The tables were of an unusual construction: framework and cushion rails manufactured using Queensland silky oak timbers and featuring an "Art Deco" styling. There was evidence that name plates had been fitted to a position on the ends of the tables but such name plates are now missing. Thorough inspection of the underside of the tables did not reveal any maker's stump or any serial numbers on the tables. The "Art Deco" styling was featured in a number of billiard tables during the 1920s and 1930s. This, together with the lavish use of Queensland silky onk in the construction of the framework suggests an appropriate dating of the tables should be in that general time period. However, somewhat at odds with that conclusion was the appearance of the underside of the slates which was suggestive of a later period. In conclusion was the appearance of the underside of the states which was suggestive of a fatter period. In sum, I regret to say that we have very little further information to offer as to the manufacturer or the precise period of manufacture of these tables; we can conclude, however, with confidence that they were not manufactured by either Alcocks of Melbourne or Heiron & Smith of Sydney.

Acting under your instructions (refer Attachment 1) to provide a valuation and review of the billiard tables sale held and sold by the Department of Parliamentary Services please see below for our opinion.

Review of sold billiard tables 2010 via internet auction.

Description: c.1989 by Herion and Smith in the "Australia Model". (This cannot be confirmed as the review was conducted by photograph.)

We are of the opinion, on the proviso that the descriptions are correct, that the \$2,500.00 (Two thousand five hundred dollars) received for each table by auction is in line with the market estimates for this type of asset.

Full size billiard tables require substantial dwellings to house and use. This is a limiting factor to the demand and subsequent sale prices achieved. Furthermore, transportation costs and installation/dismantling costs would also have to be factored in when considering purchasing a full size billiard table.

Replacement costs: Our research reveals that a new table from the same supplier, for a similar model, are quoted from \$10,000.

Sales Comparisons: 3 similar tables (ex Cooma billiard club) were sold via public auction in Cooma, NSW approximately five years ago for \$2,000 to \$3,000. It should also be noted that the market has softened considerably since this period.

Heritage Review

Also contained in the instructions received from your office was to review the heritage value, if any, of tables that may increase value.

In our opinion, the tables in question have no real heritage weighting to them due to their homogeneous character, age, and as they seem to be of a standard stock Another contributing factor would be that the tables were not commissioned as one-off pieces. Again we wish to stress that we are working with descriptions and evidence as provided.

Billiard tables held by DPS at Parliament House Canberra

Location House of Representatives Alcove

Description: These billiard tables are constructed from Queensland maple with eight heavy square form legs, full size and original hardware.

Providence: From discussion with PwC, there is evidence from the Parliament House asset registers and from documentation retained by the Parliament House Construction Authority that these tables originated from Old Parliament House. In our opinion, they are of the style of Old Parliament House in the design style "Stripped Classical Style" of John Smith Murdoch (Canberra's first Government architect). This is an opinion on the style only, however it should be noted that we have been unable to determine if they were conceptual original pieces or commissioned in the style of Old Parliament House design at a later date.

Value: Pickles Valuation Services opinion is the estimated Fair Value of these tables to be in the vicinity of \$10,000 each. It should be noted that this estimate of value was formed by applying a heritage weighting or celebrity ownership value.



Identification of heritage assets for Parliament House (DPS)

- As requested by the Secretary on 30 June 2011, we have completed a preliminary survey to identify moveable and semi-moveable items that have some heritage or historical connection and are not already managed as part of the Parliament House Art Collection (PHAC) group of cultural and heritage assets.
- This report summarises the finding of the survey which was undertaken by Ms Robyn Stewart of the Strategy and Communication section, working with Ms Kylie Scroope, Director Art Services.

Scope of work

- We have used Significance Methodology as the basis for this exercise. This methodology is recognised by the Department of Sustainability, Environment, Water, Pollution and Communities. Further details about this method and its application for this task are outlined at **Appendix A**. It is important to note that the significance criteria have been used as guiding principles only. Detailed significance assessments were not undertaken for each item.
- The focus of this preliminary survey was on items located within DPS work areas, or in the control of DPS staff. The Chamber Departments have not been approached about items of significance in their control; however, we consider it highly likely that significant Parliament House heritage material will also be held by those departments.
- 5 Virtually all areas of DPS yielded some items that merited listing.
- Items were identified across a range of different media/material types, including photographs; documents; architectural material (drawings/models); technology/tools/equipment; furniture; artwork; plants, samples (e.g. building fabric); uniforms and ephemera.

Results

- 7 170 "new" items or groups of items have been listed, as of 2 August 2011. It is our view that some of these items clearly warrant classification as cultural and heritage assets, and imposition of more rigorous control and management systems (similar to the management controls currently applied to PHAC items).
- 8 The listing is very much only a preliminary identification, as some items are part of a large group e.g. groups of photographs, or architectural drawings and

there has not been sufficient time to itemise these individually, or assess their content in detail. For the purposes of this preliminary survey a single group entry has been recorded for this type of material. There are also some 8 items or groups of items listed at the end where there is suggestion that the items existed within Parliament House, but the current whereabouts of these items has not yet been identified.

- We have developed a number of categorise to assist with evaluation of the listed items. These categories should be read only as an indicative grading, and it may well be that after further discussion or research the rating of some items will change:
 - (a) Highly significant (HS) includes items which clearly satisfy a number of the "Significance methodology" criteria, and also appear very likely to satisfy the requirements for classification as heritage and cultural assets;
 - (b) Significant (S) includes items that satisfy some significance criteria and would benefit from more rigorous control and management - these items are likely to be of slightly lesser intrinsic/financial value, but are important for their information content, or in assisting to understand, interpret and preserve the history of the building;
 - (c) Items of interest (IoI) includes items that may be significant, but require more detailed assessment or investigation. This category particularly applies to group listings, where it is possible that not all items within a group will be of equal importance (some may be duplicates), or items where we do not have appropriate expertise to make a judgement about significance (e.g. some technology items);
 - (d) Flagging for future attention (FF) includes items that may not have any great heritage significance now, but will probably accrue value with the passage of time – e.g. 'spares' of original building fabric/materials/fittings, where DPS currently holds many multiples of an item, but in future there may be only a few original examples surviving.
- 10 For the latter two categories, it may be that these items do not necessarily need to be classified as cultural heritage assets, but rather they should be recorded in accordance with archival standards and monitored, as part of ongoing activities associated with implementation of the new Heritage Framework.
- 11 A breakdown of the listing is at Appendix B.

Recommendation

- As a result of the survey of moveable heritage items it is recommended that DPS undertakes the following actions:
 - (a) create a comprehensive definition for items associated with Parliament House that have cultural and heritage significance;
 - (b) catalogue the works listed in appendix B;
 - (c) photograph each item to form part of the above mentioned catalogue;
 - (d) advise all DPS asset custodians (as listed in appendix B) of the heritage items they are responsible for and their requirement to protect them;
 - (e) advise all DPS asset custodians of the requirement to consult with our heritage specialist before any action to dispose of the item;

- (f) Art Services Section should assess if any of the identified items listed in appendix B should be transferred to the Parliament House Art Collection or possible other institutes such as OPH;
- (g) ensure the catalogue has information about maintenance/preservation;and
- (h) develop a clearer policy or process to update the cultural and heritage register as items:
 - (i) are acquired;
 - (ii) gain heritage significance as a result of events in and around Parliament;
 - (iii) are moved or disposed (including method of disposal), and including standard stocking procedures.

Appendix A – Overview of Significance methodology

Extract from http://www.environment.gov.au/heritage/publications/significance2-0/index.html

There are four primary criteria and four comparative criteria for assessing significance.

Note that one or more criteria may apply and be interrelated. It is not necessary to find evidence of all criteria to justify significance. An item or collection may be highly significant even if it is relevant to one primary criterion only. The comparative criteria interact with the primary criteria to modify or clarify the degree of significance.

Primary criteria

Historic significance

- Is it associated with a particular person, group, event, place or activity and how is this important?
- What does it say about an historic theme, process, or pattern of life?
- How does it contribute to understanding a period, place, activity, industry, person or event?

Artistic or aesthetic significance

- · Is it well designed, crafted or made?
- Is it a good example of a style, design, artistic movement or an artist's work?
- Is it original or innovative in its design?
- Is it beautiful, pleasing, or well-proportioned?
- Does it show a high degree of creative or technical accomplishment?
- Does it depict a subject, person, place, activity or event of interest or importance?

This criterion is most relevant to works of art, craft, design and decorative arts, but may also apply to items of technology, or mineral specimens or folk art. Items do not have to be art works to have artistic value. Some pictures may have little artistic significance but have historic value instead.

Scientific or research significance

- Do researchers have an active interest in studying the item or collection today, or will they want to in the future?
- How is it of interest or value for science or research today or in the future?
- Is it of research potential and in what way?
- What things in particular constitute its scientific or research interest and research value?

This criterion only applies to items or collections of **current** scientific value, or with **research potential** such as archives, natural history or archaeological collections. Items such as historic scientific instruments are generally of historic significance.

Social or spiritual significance

- Is it of particular value to a community or group today? Why is it important to them?
- How is this demonstrated? How is the item kept in the public eye, or its meaning kept alive for a group? For example, by use in an annual parade or ceremonies, or by maintaining traditional practices surrounding the item.
- Has the community been consulted about its importance for them?
- Is it of spiritual significance for a particular group?
- Is this spiritual significance found in the present?
- Does it embody beliefs, ideas, customs, traditions, practices or stories that are important for a particular group?

Social or spiritual significance is always specific to a particular, identified group of people. This type of significance only applies to items and collections where there is a **demonstrated**

contemporary attachment between the item or collection and a group or community. Items or collections of social history interest are of historic significance. Religious items that are no longer used are more likely to be of historic or artistic significance. If the item or collection has spiritual or social significance, this should be demonstrated through consultation with the community or group.

Comparative criteria

Four comparative criteria are used to evaluate the **degree** of significance. They interact with the primary criteria and may increase or decrease significance. For example, if the item is well provenanced it will generally be more significant; if it is in poor or incomplete condition, it will generally be of lower significance. Items or collections must be significant under one or more of the primary criteria. They cannot be significant if only the comparative criteria apply.

Provenance

- Is it well documented or recorded for its class or type?
- Who created, made, owned or used the item or collection?
- Is its place of origin well documented?
- Is there a chain of ownership?
- Is the provenance reliable?
- How does the provenance shape the significance of the item or collection?

Provenance is part of the research in the assessment process as well as a comparative criterion.

Rarity or representativeness

- Does it have unusual qualities that distinguish it from other items in the class or category?
- Is it unusual or a particularly fine example of its type?
- · Is it singular, unique or endangered?
- Is it a good example of its type or class?
- Is it typical or characteristic?
- · Is it particularly well documented for its class or group?

In some cases items may be both rare and representative, such as examples of nineteenthcentury working dress. An item that is merely representative is unlikely to be significant. It has to be significant under one of the primary criteria.

Condition or completeness

- Is it in good condition for its type?
- Is it intact or complete?
- Does it show repairs, alterations or evidence of the way it was used?
- Is it still working?
- · Is it in original, unrestored condition?

In general, an item in original condition is more significant than one that has been restored.

Interpretive capacity

- How is it relevant to the organisation's mission, purpose, collection policy and programs?
- Does it have a special place in the collection in relation to other items or a collection theme?
- Does it help to interpret aspects of its place or context?

The statement of significance


A statement of significance is a reasoned, readable summary of the values, meaning and importance of an item or collection. It is more than a description of what the item or collection looks like. A statement of significance summarises **how** and **why** the item or collection is

important. It is supported by research and evidence assembled through the assessment process.

The statement of significance incorporates all of the elements that contribute to the meaning of items and collections including appearance, fabric, design, context, environment, history, provenance, uses, function, social values and intangible associations.

Drawing all these values and attributes together into a statement of significance is an effective way of communicating and sharing knowledge about why an item or collection is important, and why it has a place in a public collection.

A statement of significance can be prepared for a single item, for a particular collection theme or subject, or for a whole collection. Significance is not set in stone and may change over time. From time to time it should be reviewed as circumstances change and knowledge develops.




