## Indigenous alcohol inquiry continues in Brisbane

The House Standing Committee on Indigenous Affairs will be holding a public hearing in Brisbane on Friday, 20 June 2014, as it continues to gather evidence for the inquiry into the harmful use of alcohol in Aboriginal and Torres Strait Islander communities.

The Committee will hear evidence from the Queensland Government and a range of groups and individuals including the Queensland Aboriginal and Islander Health Council, Synapse, Professor Heather Douglas and Professor Peter D'Abbs.

The Committee Chair, Member for Murray, Dr Sharman Stone MP, expects a broad range of issues to be covered at the hearing.

Dr Stone said: "While substantial and commendable efforts have been made in Queensland by communities and the government to minimise alcohol related harm in remote communities, the majority of Aboriginal and Torres Strait Islander people live in regional and urban parts of the state. The Committee anticipates that the evidence given in Brisbane will help identify strategies that are best practice and can help bring about change in all indigenous communities, regardless of where they are."
