Grant Potatoes SA endeavours to combat the risk to the Australian potato industry posed by the import of overseas
Kingston potatoes.

Naracoorte Lucindale This issue has been drawn to the attention of our member Councils who have in turn highlighted their
Robe concerns about the impact it is likely to have on their growers, the industry and their communities. While we
Tatiara will seek and expect the support of the Local Government Association of SA on this matter we realise that a
Wattle Range Senate Inquiry will be held in Canberra on Wednesday 24th October 2012 and this presents an immediate
opportunity for Local Government to act in support of regional agribusiness and communities by adding our
combined weight to your submission.

To our knowledge, South Australia is involved in all facets of potato production including fresh, washed
potatoes, French fry, crisping and seed sectors and produces over 385,000 tonnes per year and is the
nation's largest producer of fresh potatoes and a significant contributor to the processed market, employing
over 2,000 people.



This issue is a serious concern to the Australian potato industry and to growers and others in the value chain
in other areas in South Australia and interstate. We support the Murray and Mallee Local Government
Association (MMLGA) bringing this issue to the attention of the South Australian Regional Organisation of
Councils (SAROC) committee with the aim of enlisting the full support of the LGA SA to lobby appropriate
Government Ministries.

Our Associations are fearful for the future livelihood of the South Australian potato industry with a recent
Federal Government report suggesting reversing an import ban on NZ potatoes. This matter has been raised
with the South Australian Parliament's Select Committee on Sustainable Farming Practices at their current
circuit of regional hearings in October 2012.

This letter acknowledges the significant consultation at an industry, community and scientific level that has contributed to the formal submission lodged by Potatoes SA. Our Local Government connections with our community members reinforce the deep concerns expressed in your submission.
