

Dear Senator

Further to yesterday's hearing I provide the following examples of cost increases on specific shipments and suggested charges moving forward for AQIS charges on Health and Halal certificates to minimise the impact on airfreight shipment.

1. Airfreight to Dubai – shipped May 2009 with 4 Meat Health Certificates at \$12.00 each (now \$49.00 each) and 4 Halal Certificates at \$31.00 each (now \$100.00 each). All up documentation cost paid to AQIS of \$172.00 at the time – now it would be \$ 596 for same shipment, a \$ 424 increase (347%), an extra cost across this shipment of \$ 0.31 per kg to a total of \$ 0.43kg. Multiple Certificates out of Est No 239 are a result of different operators given it is a co-operative there with each providing their own RFP to us at Inspected status to be sent to print.

RECOMMENDATION – That Meat Health Certificates and Halal Certificates for quantities under 1400kg be invoiced at the old level prior to the start of these increases at \$12.00 for Meat Health Certificates and \$31.00 for Halal Certificates.

2. Airfreight to Vietnam – shipped in July 2009 with 5 Meat Health Certificates at \$12.00 each (now \$49.00 each) 1 Seafood Health Certificate at \$40.00 (now to be \$33.00 with our own authorisation of these) and one Dairy Health Certificate at \$21.00 (to remain at \$21.00). All up documentation cost paid to AQIS of \$121.00 at the time – now it would be \$ 299 for same shipment, a \$ 178 increase (247%).

RECOMMENDATION – That Meat Health Certificates and Halal Certificates for quantities under 1400kg be invoiced at the old level prior to the start of these increases at \$12.00 for Meat Health Certificates and \$31.00 for Halal Certificates.

An alternate recommendation if split pricing on Health and Halal Certificates on weight will not work from an AQIS systems point of view is that ALL Health and Halal certificates be invoiced on a cent per kg basis across all certificates regardless of quantity (airfreight or seafreight) such that it raises the same revenue as the current proposed model.

3. One RFP – multiple Health certificates. Attached is a copy of RFP for one shipment with more than 15 line items. Given this it prints on 2 Health certificates and attached is AQIS invoice showing charge for 2 Health Certificates.

RECOMMENDATION – That an exporter is charged for 1 Health certificate per RFP regardless of the number of Health certificates that print.
