THAT I (MONICA - HER BABY DAUGHTER)

MY MOTHER HUMAN RIGHTS WERE NEVER CONSIDERED, SIMPLY BECAUSE SHE WAS A NO-BODY - NO ONE CARED BACK THEN, BUT I DO & ALWAYS WILL!

SECONDLY, I LIKE MY MOTHER, WAS MADE A VICTIM OF THIS INTUNCTION - FOR I WAS ALSO DENIED MY HUMAN RIGHTS TO KNOW THE TRUE IDENTITY OF MY MOTHER & THAT OF MY OWN UNTIL THE MID 1980S (THIS WAS ONLY THROUGH MY INVESTIGATION & THE BURNING NEED TO KNOW, BECAUSE OF THIS INTUNCTION, I WAS DULY PUNISHED NOT TO KNOW & SENTENCED TO ADOPTION WHICH I SOON DISCOVERED WAS "THE ULTIMATE JUDAS ACT OF BETRAYAL" NOT ONCE, BUT TWICE.
