To whom it may concern on the Committee of the Senate Legal and Constitutional Affairs,

On behalf of Fagron Compounding Supplies Australia, we would like to submit an offer of support to the Legal and Constitutional Affairs Legislation Committee regarding the Regulator of Medicinal Cannabis Bill 2014.

With a strict distribution model, the OMC is able to ensure all its responsibilities are addressed. Appendix 1 shows the process by which medicinal cannabis is supplied under the OMC in the Netherlands. By replicating this model, the Australian government could implement a high quality, regulated system for distribution of medicinal cannabis. For this reason, Fagron is in full support of this bill and the formation of the Regulator of Medicinal Cannabis.

In addition to the medical practitioner, member of the Australian Federal Police and representative for patients, we urge the committee to also include a pharmacist as a member of the regulator. Pharmacists are instrumental in the quality assurance of medicines and counselling of patients undergoing the treatment, therefore should be included as part of the Regulator of Medicinal Cannabis in Australia.

Appendix 1 – Production and distribution model of OMC

Our production and distribution model:

- 1. After taking in the harvest of medicinal cannabis (by an employee of the OMC) the harvest goes to the packager.
- 2. From every harvest a sample goes to the laboratory to check the medicinal cannabis on pesticides, fungi, heavy metals etc. and also on the THC and CBD-level.
- 3. After the medicinal cannabis has been packed an employee of the OMC goes to the packager to check and count it.
- 4. When the lab results are in and ok, the pharmacist of the OMC makes an certificate of analysis and then the batch is ready for sale.
- 5. Medicinal cannabis is only available on doctor's prescription and only available in the pharmacy
- 6. A pharmacist can order the medicinal cannabis with a recipe at our pharmaceutical wholesaler
- 7. The pharmacist provides it to the patient
