Answer:

The department has identified three suppliers who are currently providing services under the Indigenous Procurement Policy (Policy) who were also providing services prior to the commencement of the Policy.

The department does not collect data on whether a supplier has tendered as part of a joint venture or on a standalone basis. Since 2015, the department has procured services through 49 unique Indigenous businesses.
