Dear Senators -

I write to inform you of my **wholehearted support** for the <u>Health Insurance (Medicare Funding for Certain Types of Abortion) Bill 2013</u>, and ask you to support its passage.

Sadly, particular ethnic and cultural groups around the world treat the impending birth of a child with grossly different responses depending SOLELY on the gender of a child.

Overwhelmingly, such responses may be summarised as:

- a SON is WELCOME! But
- a DAUGHTER is NOT!

The cultural expectations of sons as carers for elderly parents, and of daughters as "burdens" for whom parents must provide a dowry, distorts the worth of each person, who should be valued for WHO – and NOT "WHAT" – that person IS (NOR what each person HAS). The two most populous nations on Earth – China and India – have large parts of their populations who, we are lead to understand, subscribe to such beliefs.

There may well be other cultures who subscribe to this pro-male viewpoint. But to extend a pro-male preference to selective abortion of girls is indeed discrimination of the worst – and deadliest – kind.

There may well be other cultures or other parents who subscribe to the opposite view – that boys are to be denied life, and that ONLY the lives of girls are to be preserved. Both are equally wrong and equally disastrous.

Woe to us if such practices are to be found in egalitarian Australia!

But indeed they have.

In January 2011, a Victorian couple challenged at the Victorian Civil and Administrative Tribunal the rejection of their bid for further *in vitro* fertilisation by the Patient Review Panel.
