Dear Minister

Thank-you for the opportunity to provide a written submission on the Aboriginal Land Rights and Other Legislation Amendment Bill 2013 ("the Bill").

PATTA

Schedule 2 of the Bill adds Northern Territory Portion 7021, an area of approximately 11.37 hectares, to the description of Patta in Schedule 1 of the *Aboriginal Land Rights (Northern Territory) Act 1976 (Cth)* ("the ALRA"). This enables the land in question to be granted, subject to completion of conditions precedent agreed between the Northern Territory and the Central Land Council on behalf of the traditional owners, to the Warti-Yangu Aboriginal Land Trust. The Northern Territory Government supports the scheduling.

JABIRU

Background

The Northern Territory was provided with a copy of the Exposure Draft of the Bill by the Section Manager, Land Rights Policy, Department of Families, Housing, Community Services and Indigenous Affairs on 7 December 2012 in the context of our respective Governments negotiated settlement of the Jabiru Native Title Claim. The Northern Territory provided comments on the Bill via correspondence dated 24 January, 18 February and 1 March 2013.

The Bill is a significant Bill affecting land and stakeholders within the Town of Jabiru in the Northern Territory.

The Bill is proposed by the Commonwealth Government to give effect to the key features of an offer of settlement made by the Commonwealth Government to the Mirarr People (the Mirarr Native Title Claimants") in 2009 to resolve the Mirarr People's application for a



determination of native title, lodged in the Federal Court of Australia in 1997 ("the native title claim").

In making the offer of settlement to the Mirarr Native Title Claimants, the Commonwealth Government noted that:

- the Government's offer to "schedule" the Jabiru Township land was a significant shift in policy;
- the Government's position reflects the unique circumstances which arise at Jabiru and which warrant a unique resolution outside the ordinary range of options for settling native title claims;
- the offer to "schedule" the Jabiru Township and adjacent non-Township areas was conditional upon an immediate 99 year leaseback to the Commonwealth;
- it was important to include the Northern Territory Government in discussions due to its responsibility for land management and service provision; and
- given the acknowledged significance of the Commonwealth's offer to meet the Mirarr Native Title Claimants' aspiration for recognition of their traditional ownership, that the Commonwealth would not be required to pay rent.

The Northern Territory gave in-principle support to the Commonwealth Government's proposal to settle the Jabiru Township native title claim on the basis that there existed a shared policy understanding between our respective governments that Jabiru would develop as a town servicing the needs of the region and providing opportunities for sustainable community development and business investment.

The Northern Territory supports the proposal to grant the Township as Aboriginal Land even though Jabiru was not claimed by the Mirarr People under the ALRA and nor was it available for claim under the ALRA. When enacted, the ALRA "scheduled" as Aboriginal Land former reserves, some of which included large communities. As a result, there are some towns on Aboriginal Land. Long-term leasing arrangements, especially long-term whole of township leases are favoured by the Commonwealth for all existing large communities on Aboriginal Land to mirror, to the greatest extent possible, ordinary freehold tenure. If a town is not already on ALRA land, the Commonwealth's position remains not to make the town Aboriginal Land. In that context, the Commonwealth's proposal to schedule the Town as Aboriginal Land under the ALRA is an exception. The Northern Territory supports the Jabiru settlement proposal even though, as a matter of law Township areas are not available for claim under the ALRA.

We also note the Principal Recommendations of the Ranger Uranium Environmental Inquiry Second Report before Commissioner Justice Fox in 1977 that the land which constitutes the Town not become Aboriginal Land but become part of the national park.

The Bill generally gives effect to the legal framework of the settlement offer made by the Commonwealth in 2009 to the Mirarr Native Title Claimants and the subsequent variations to that settlement offer agreed between the Commonwealth, the Northern Territory and the Mirarr Native Title Claimants in 2010. Namely, the Bill provides for a deed of grant to be delivered (effected) upon either:

(a) section 19 Aboriginal Land Rights (Northern Territory) Act 1976 (Cth) ("ALRA") leases being granted to the Director of National Parks (Category A Jabiru Land), an Aboriginal and Torres Strait Islander corporation nominated by the Northern Land Council (Category B Jabiru Land) and the Northern Territory (Category C Jabiru land); or

(b) a section 19A ALRA lease of all of the Jabiru Town Land to the Commonwealth.

The key features of the settlement framework as set out in the Bill also include:

- 1. the surrender of the Director of National Parks' freehold estate in the claim area, including the Jabiru Township;
- 2. the preservation of any existing right, title or interest or anything (including, all existing subleases) on the same terms and conditions until 2021 (the date upon which the current headlease and subleases expire); and
- 3. the preservation of the ownership of Jabiru Town infrastructure or fixtures by the Northern Territory. As the Commonwealth has previously advised the Northern Territory, the Commonwealth will not amend the Bill to preserve rights, interests or obligations under the 1985 Cost Sharing Agreement between the Jabiru Town Development Authority and Energy Resources of Australia.

Thus, the land proposed to be scheduled will not be granted as Aboriginal Land unless and until leaseback arrangements are agreed. As the Northern Territory Government has previously advised the Commonwealth, the Northern Territory's preference is for the section 19 ALRA leases currently being negotiated with the Mirarr Native Title Claimants.

Deeds of Grant Conditional Upon 99 Year Headlease

The implementation of the Commonwealth's settlement offer involves complex legal and policy issues. The practical effect of the Bill, if passed, is that it will not resolve all outstanding issues regarding the implementation of the Jabiru settlement including, in particular:

- the terms and conditions of a new Town headlease for Jabiru and subleases, including the principles upon which non-Government sublessees are to be transitioned to rental payments;
- completion of a new Jabiru Planning Scheme and arrangements under the NT Planning Act and the Commonwealth Environment Protection and Biodiversity Conservation Act;
- a variation to the 1985 Cost Sharing Agreement between the Northern Territory of Australia and Energy Resources of Australia;
- permit free access to the town once it becomes Aboriginal Land; and
- arrangements for access to town infrastructure.

The Bill will therefore not obviate the need for the ongoing negotiations currently being undertaken by the Northern Territory with the Mirarr People.

Jabiru is an important regional service centre in the Northern Territory, the only township within the Kakadu National Park, and catering for business, residents, and tourists to the region. Business operators at Jabiru have, for some time, expressed legitimate concerns that the current headlease for the town will expire in 2021. This has resulted in existing sublessees being unable to secure finance and investment in the Town declining.

Against this background, it is crucial that the new Jabiru Township headlease - a condition precedent to the Jabiru Town land and adjacent areas being granted as Aboriginal land - adequately provides for flexibility and growth and meets the best long term interests of the

Northern Territory, the Mirarr traditional owners and other stakeholders, in a balanced manner. It is vital that the parties develop a Head lease which recognises Jabiru as a town of strategic importance to the Territory, one which will play a significant role in the future of the Kakadu region and recognises the Territory as a key stakeholder.

Description of the Land to be Scheduled

Section 27 of the Bill inserts at Part 4 of Schedule 1 of the ALRA, under the heading "Jabiru":

"All that land in the Northern Territory comprising:

- (a) the whole of Northern Territory Portion 2271 delineated on Survey Plan S77/144B lodged with the Surveyor-General, Darwin, and containing an area of approximately 5.14 hectares; and
- (b) the whole of the Jabiru town land (see section 3AC of this Act) [section 3AC refers to "the boundaries of the land comprising the whole of former Northern Territory Portion 2272 delineated on Survey Plan S79/31 lodged with the Surveyor-General, Darwin"]; and
- (c) the whole of Northern Territory Portion 2273 delineated on Survey Plans S77/144A, S77/144B, S77/144C and S77/144D lodged with the Surveyor-General, Darwin, and containing an area of approximately 5,502 hectares."

As has already been noted by the Northern Territory, the Northern Territory remains concerned that the Bill does not provide a proper description of any of the areas of land proposed to be scheduled. Further, the Northern Territory is concerned that despite comprehensive survey work being commissioned by the Northern Territory to identify the areas of land to be scheduled and the particulars of the completed survey work having been provided to the Commonwealth, the Commonwealth has advised that it does not propose to amend the Bill to correctly identify the areas of land to be scheduled.

Following survey work being undertaken for the purposes of the Commonwealth's settlement offer, the following represents the proper description of the land proposed to be granted as Aboriginal Land:

- (a) the whole of Northern Territory Portion 7126 delineated on Survey Plan S2011/202 lodged with the Surveyor-General, Darwin, and containing an area of approximately 3.96 hectares; and
- (b) the whole of the land listed in Attachment A; and
- (c) the whole of Northern Territory Portion 7127 delineated on Survey Plans S2011/203A and S2012/203B lodged with the Surveyor-General, Darwin, and containing an area of approximately 5469 hectares.

We confirm all road lots are excluded from (b) above.

We confirm the Department of Families, Housing, Community Services and Indigenous Affairs advised the Northern Territory in January 2013 that the particulars of the completed survey work commissioned by the Northern Territory would be used as the basis upon which the land proposed to be scheduled would be described in the Bill.

Thus, the Northern Territory is most concerned that the Department of Families, Housing, Community Services and Indigenous Affairs has, in the last week, changed its position and advised the Northern Territory that as it anticipates the Bill will be debated in the House of Representatives after Federal Parliament resumes on 14 May 2013 for the Winter Sittings

that no amendments are proposed to the Bill (including in relation to the Jabiru land description issues). We are also concerned at the Department's suggestion that the process under sections 12AA and 12AC of the ARLA be engaged to identify public roads on land comprising the former Northern Territory Portions 2271 and 2273 at the time of execution of deeds of grant. We note this is the first time this approach has been raised with the Northern Territory.

As the Northern Territory has, with the support of the Commonwealth, proceeded with and completed the surveying processes for the former Northern Territory Portions 2271 and 2273 (which we confirm are cancelled titles), it will be necessary for the Commonwealth to amend the Bill to ensure that a deed of grant referring to these portions is capable of being registered in accordance with section 12(5) of the ALRA and that the relevant provisions of the Bill and the proposed deeds of grant will be of legal effect and operative. In that regard, we respectfully request the Committee amend the Bill in the manner previously advised to the Commonwealth and referred to in this submission.
