# Introduction

I (Trevlyn) am a husband, father of four beautiful children, work full time in Hobart as a manager in a prominent national business and founded Reformed Resources (a ministry of Anselm Study House). I became an Australian citizen in 2001 and have lived in this great land since 1999. I (Susannah) am a wife, mother of four, home educator and registered nurse. I am an Australian citizen and completed my Bachelor of Nursing at Avondale College.

We write this submission in support of Senator John Madigan's Health Insurance Amendment (Medicare Funding for Certain Types of Abortion) Bill 2013, presented to the Senate on 19 March 2013. It is urgent that this Bill be passed through the Senate.

Australian taxpayers should not be funding abortions; they especially should not be funding abortions on the basis of gender selection. Unborn girls (in particular) need protection; Senator Madigan's Bill is a step towards protecting the human rights of little girls in utero.

This Bill is a fundamental step towards eliminating the deadliness of the three most ominous words in the world; "it's a girl."<sup>1</sup> Sex-selective abortions are a problem around the world;<sup>2</sup> England<sup>3</sup> and Australia are not immune to this practise.<sup>4</sup> The Senator's Bill provides protection to the next generation of women (sisters, aunts, mothers, grandmothers) from termination simply due to their femininity.

# 113 million to 200 million women missing in the world today

The United Nations estimates that, up to, a staggering 200 million women are missing in the world today due to infanticide.<sup>5</sup> According to DCAF: "...put in the most horrible terms: violence against women causes every 2 to 4 years a mountain of corpses equal to the Jewish Holocaust."<sup>6</sup> UNICEF argued that gender selective abortion creates the mindset that women are a "disposable gender," which has caused an increase in violence, sex trafficking and child abduction.<sup>7</sup> This is shocking. Australia must do something to turn the tide. We ought to seek to be leaders in the protection of the weak and vulnerable in our society. Senator Madigan's Bill provides a framework to do exactly that. I strongly urge you to vote in favour of protecting our girls from being terminated simply because they are girls.

# Gender selective abortion is gender discrimination against girls

In 1994 the United Nations condemned gender selective abortion and sort the elimination of "...all forms of discrimination against the girl child and the root causes of son preference, which result in harmful and unethical practices regarding female infanticide and prenatal sex selection."<sup>8</sup> The World Health Organization (and OHCHR, UNFPA, UNICEF and the UN) also strongly condemned gender selective abortion: "sex selection in favour of boys is a symptom of pervasive social, cultural, political and economic injustices against women, and a manifest violation of women's human rights."<sup>9</sup>

Gender selective abortion is a war against women. In fact it is a slaughter of (future) women and it must be noted that the number victims surpasses the tragic, bloody Communist/Socialist (20<sup>th</sup>) century.<sup>10</sup>

# Australians reject gender selection abortion

The latest Galaxy Poll, on this issue (at time of writing), conducted in Tasmania on Tuesday 9 February 2013 clearly revealed that 92% of people are opposed to gender selective abortion.<sup>11</sup> Research has shown that Australians are overwhelmingly opposed to gender selective abortion.<sup>12</sup> It must also be noted that gender selective abortion is not limited to far away China, India or elsewhere; it is alive and present in Australia.<sup>13</sup>

Gender selective abortion is even offensive to the progressive socialist World Health Organization; praise God Almighty for this, especially since this position is inconsistent with the progressive movement.

#### Australian law was founded on Biblical Law

Australia is one of the most peaceful nations in the world and we enjoy a standard of living that most other countries envy. We must ask why. What is the reason for our peace and prosperity? As you know, our nation is part of the British Commonwealth; our legal and cultural heritage is tied closely to that of Britain/England. The history of our (common) law is directly linked with English Common Law, which dates back to King Alfred the Great in the 9<sup>th</sup> century. Alfred rallied England and upon successfully defending her from the ravages of the invading Vikings/Danes he established the English Law Code. Alfred's Book of Laws or Dooms codified what became England's Common Law. This Law blended Biblical Mosaic Law with the Christian principles of Celto-Brythonic Law. Senator Madigan's Bill seeks to honour God and our forefathers by curbing the shedding of innocent blood.<sup>17</sup> No little girl should be murdered in utero due to the fact that she is a little girl. The debate is not between politics and religion or science and religion; rather it is over which religion will be codified in our nation's laws.

## Taxpayer funded abortion is a violation of religious liberty

Our nation's Laws have historically been the codification of the Christian religion. This legal framework has produced one of the safest, wealthiest and freest societies in the world. Taxpayer funded abortion via Medicare is a violation of the religious liberty of those who are against this atrocity. No government should fund abortions from taxpayers. It is simply a violation of the religious liberty that our Australian Constitution seeks to protect. By forcing me (or any Christian) to fund abortions (via Medicare) the government is forcing me (and all Christians) to go against conscience and condone the murder of innocent life. This Bill needs to be commended as it seeks to slow down the flow of taxpayer money to abortion.

#### Conclusion

We urge you to seek the Almighty God's blessing, as the Constitution does, by ensuring that the Laws of our Land reflect the Law of the Scriptures (rightly interpreted); and protect the lives of the most vulnerable. If you do not support the abolishment of Medicare funded gender selective abortion – repent of your sins. Turn away from seeking to murder those who are weak and seek to protect them. As Senators you are charged by God Almighty to protect the weak in our society, we beseech you to do so.
