Public hearings in Coober Pedy, Ceduna and Adelaide for Indigenous Affairs Committee

The House Standing Committee on Indigenous Affairs will be holding hearings in South Australia, as it continues to gather evidence for the inquiry into the harmful use of alcohol in Aboriginal and Torres Strait Islander communities. The Committee will hold public hearings in Coober Pedy on Monday 4 May, and Ceduna and Adelaide on Tuesday 5 May.

In Coober Pedy the Committee will hear from the Mayor as well as Aboriginal Health organisations and representatives of the Aboriginal Family Support Services and local hospitals.

Witnesses at the public hearing in Ceduna include the Mayor, the Ceduna Aboriginal Corporation and the Ceduna Koonibba Aboriginal Health Service Aboriginal Corporation.

In Adelaide the Committee will hear from groups such as Drug and Alcohol Services, SA and the Aboriginal Legal Rights Movement.

The Committee Chair, Dr Sharman Stone MP, said "We know that towns like Coober Pedy are concerned about the impact of alcohol on their community. The Committee is interested in hearing how the recently developed Alcohol Management Plan provides a framework for minimising the harmful impact of alcohol in Coober Pedy."

Dr Stone stated "The harmful effects of alcohol can be felt throughout a community. Family members, members of the community, service providers and emergency services all feel the impact of alcohol on their daily lives and work."

'The Committee wants to hear more about how communities are impacted as well as examining what works to reduce the harms, with a particular focus in these hearings on communities coming together to respond to the impact of alcohol,' she added.
