
Also, please receive the attached presentation of how babies are murdered and consider if this outrageous act should be a criminal offence.


Are you aware of the real facts?




1—THE VACUUM SUCTION METHOD—THE BABY COMES OUT IN LITTLE PIECES!

LIKE A VACUUM CLEANER CLEANER CLEANING UP DIRT.




2—THE D. AND C. METHOD (CURETTE)



THE DOCTOR CUTS AND TEARS THE BABY TO PIECES INSIDE THE MOTHER AND SCRAPES IT OUT.


3—THE SURGICAL METHOD (HYSTEROTOMY)

5—PROSTAGLANDINS INJECTION


A POWERFUL DRUG IS INJECTED INTO THE MOTHER TO BRING ON THE BABY'S BIRTH
