I've had 4 operations to remove it. After the last surgery Dr [REDACTED] performed on me, which from memory was in 2011, he promised me he had removed all of the mesh but with the ongoing pain & suffering worsening, in desperation I went back to him early 2014, convinced I still had some mesh. He reiterated that all the mesh had been removed & sent me to Dr [REDACTED] [REDACTED] for assessment to see if I would be suitable for an injection to help with the incontinence. It was during consultation with her & tests over 2 days in hospital, that she discovered I did in fact still have some mesh in me, so I was once again booked in for removal surgery.

I am at a loss to suggest anything other than not to use this product anywhere in the world.

Terms of Reference 3: Information provided to doctors regarding transvaginal mesh implants and possible complications and side effects

I have no knowledge of what the doctor's know other than Dr [REDACTED] telling me that some patients have problems with the mesh. I was never told it may cause serious problems nor that it might need to be removed.

I don't know what my doctor was aware\nnot aware of. The only information I have had is what I have seen on support group sites where I learned I was not alone & shocked to find this is a common issue amongst so many patients.
