## Inquiry into Telecommunications Amendment (Mobile Phone Towers) Bill 2012 Community Supplementary Submission following the Environment and Communications Legislation Committee hearing Thursday 12 April 2012

## **Purpose**

The purpose of this supplementary submission is provided to clarify potentially misleading information presented to the committee, and explain why the information provided to the committee might be considered partial or incomplete.

The WHO say: Considering the very low exposure levels and research results collected to date, there is no convincing scientific evidence that the weak RF signals from base stations and wireless networks cause adverse health effects"	This comment is misleading to the committee, as it is out of date.  Mr Mckenzie's quote is taken from a WHO fact sheet titled "Electromagnetic fields and public health, Base stations and wireless technologies" dated May 2006  Mr Mckenzie makes no reference to the International Agency for Research on Cancer, part of the WHO who classified EMR emitted by handsets as a class 2B Carcinogen in June 2011.  The Electromagnetic radiation emitted from handsets is the same electromagnetic radiation emitted from base stations					
13/14	Mr Stanton states" but I think it is worth noting that the existing code has had a dramatic effect on the number of complaints received by the ACMA about the deployment of mobile base stations. Back in 2002, when the code came into play, we were seeing something like 140 complaints per annum to the ACMA. In recent years that has hovered around the eight to 10 mark"	This comment is misleading to the committee, as The ACMA do not record all complaints made by communities  It is unclear whether the ACMA's complaints recording and investigation procedure has changed between 2002 and 2012. We understand The ACMA's current register of complaints excludes telephone complaints, and some formal complaints are not registered by the ACMA, for example a formal written complaint from Rainworth State School P&C in Bardon  The complaints procedure under the ACIF code is bureaucratic, cumbersome, difficult to follow, with many restrictions, including only being possible following the submission of the carriers' final report to Council, and following investigation by the carrier, by which time most communities' disband as the fight has already been lost. This is illustrated by the ration of anti tower media coverage that results in formal complaints to the ACMA.  No Towers Near Schools is aware of over 160 communities (Attachment 1), in every state, reported in the media, which have objected to Mobile phone base stations in their communities in recent years these are not represented in the ACMA's complaints register.

Interphone collected data for  • Average users (4-6 minutes a day) and high users (top 10%) who used a mobile phone for 30+ minutes a day for 10 years  • Adults only. No data was collected for children's use  • Cancers that were first diagnosed between 2000 and 2004.  • 13 Countries excluding the USA.  Based on the above data set, the IARC study, known as Interphone reported that "overall, there is no clear connection between cell-phone use and brain cancer. "An increased risk of brain cancer is not established from the data from Interphone".  Interphone also reported that high end users (10% of people making calls for more than 30 minutes a day over 10 years) increased their risk of developing gliomas - a type of tumor that starts in the brain or spine - by 40%.
		Time Magazine <sup>1</sup> reports that in the USA the average use is now 21 minutes per day. (Interphone's average was 4-6 minutes per day and heavy user was 30 minutes a day), Interphone does not take into account the impact of mobile-phone use in children, whose skulls are thinner than adults, and who may be more sensitive to cell-phone radiation. Nor does it include any data on U.S. users.  The data for interphone was collected between 2000 and 2004, results from interphone were not published until 2010. Interphone was not a 10 year study  Since the Terms of Reference were established for interphone in the 1990's mobile phone usage in Australia has increased from 9 million subscribers in 2000 <sup>2</sup> to 28 Million in 2011.

The Precautionary Principle states when there are indications of possible adverse effects, though they remain uncertain, the risks from doing nothing may be far greater than the risks of taking action to control these exposures. The Precautionary Principle shifts the burden of proof from those suspecting a risk to those who discount it.  The International Commission for Electromagnetic Safety (ICEMS) held an international conference entitled . The Precautionary EMF Approach: Rationale, Legislation and Implementation., hosted by the City of Benevento, Italy, on February 22, 23 & 24, 2006. Dr Martin: The impact of new imaging technologies means that, when someone dies of what might have been called a stroke in old age, the odds are that you will now image it properly and you will say, 'It wasn't a stroke; it was actually a brain tumour,' or something like that. Better imaging means that a lot of brain tumours that were missed would now have been seen

This statement is misleading to the committee, as it fails to recognise that If the increase were due entirely to improved detection, one might expect to see a plateau and then a reduction in new cases once the better detection method is adopted

Many scientists believe that the reported increase in brain tumors is due to improved detection of the disease through use of CT (computerized tomography) and MRI (magnetic resonance imaging) (Smith *et al.* 1998; Smith *et al.* 2000). These scientists point particularly to the increases in diagnosed brain tumors in the elderly and contend that in the past these tumors would never have been diagnosed.

Other scientists argue that the increase is not likely to be fully explained by improved diagnosis, especially in children, because in young people brain tumors do not go undetected for very long, regardless of the method used (Kaiser 1999). Moreover, the increase appears to have continued for many years (Bleyer 1999).

31 **Dr Martin:** I think it is usually done, as it probably is in other areas, normally by extrapolation. For example, we have been exposed to broadcast radio and television in our societies for

we have been exposed to broadcast radio and television in our societies for 50, 60 and 70 years. For most of what the physics tells us there is not a great deal of difference between microwave radiation used for mobile phones and UHF television signals, for example. They are done with lower powered transmitters distributed more widely in the community but the actual stuff that is coming out of the

antenna is, as far as we

know, the same.

This statement is misleading to the committee, as it is disputed that emissions from radio and television antennas are similar to microwave antennas

EMR is waves of electric and magnetic energy moving together through space. It may be of natural or of artificial origin (e.g. as used in mobile phone technology). It may be in the form of non-pulsed waves or pulsed waves, which may produce thermal (the ability to increase body temperature by one degree Celsius) and non-thermal (biological) effects. It is the safety of the <u>non-thermal effects of pulsed waves</u> being debated by the international scientific community, and of concern to communities.

Telephone signals are pulsed, whereas TV and radio signals are continuous. There are significant differences in the frequency. Phones (800-900Mz, 1800 MHz and higher), TV (50-300 MHz) and radio (FM is around 100 MHz) operate. It is the high frequency and pulsing action of the EMR from mobile phone technology that can potentially have greater non-thermal biological effects on the body at cellular level

EMR from TV antennas have been part of our lives since before we were born, as a result the long term effects on the body are known. Mobile phone technology is in its infancy, long term effects are unknown.


It has been predicted that the high frequency pulsed signals from mobile phone technology may cause adverse cellular effects on the body. Particularly the bodies of growing children and the elderly. There have been no very long term studies completed on this and no studies of any kind on children.

36 **Dr Larson**: The transmitter in a mobile phone handset is something like one hundredth or two hundredths of the power of a mobile phone base station. But it is only centimetres away from your head, so you collect a much bigger fraction of the emitted radiation from a handset than

you do from a phone tower

This statement is misleading to the committee, as it implies towers are always located away from people

The attached photo from Lenox Heads shows a proposed tower approx 5m from a residential bedroom, with EMR 100 to 200 times the emission from a hand set 24 hours a day





43	Mr Loney They could take measurements themselves or—	This statement is misleading to the committee, as it implies it is straightforward and cost effective for members of the public to take their own EMR readings  In Bardon Brisbane City Council engaged an independent report into EME readings in the area, We understand this cost in the order of \$5,000. Specialist measuring equipment is understood to cost approximately \$10,000, and requires training in how to take measurements in accordance with ARPANSA's standards. As such is not practical for community members to take measurements  This statement is incomplete.  In urban areas there are a greater number of lower power base stations, however they have overlapping coverage with adjacent base stations, otherwise there would be "black spots" of no coverage. In addition the three carriers each erect their own towers within a single area  The existing EME assessment and reporting requirement do NOT require carriers to take into account existing EMR emitted from adjacent base stations, or other carriers.
