Inquiry: the Third party certification of food The Terms of Reference:

On 13 May 2015, the Senate referred the following matters to the Economics References Committee for inquiry and report by 30 November 2015:

- a. the extent of food certification schemes and certifiers in Australia including, but not limited to, schemes related to organic, kosher, halal and genetically-modified food and general food safety certification schemes;
- b. current labelling requirements of food certification schemes;
- c. the need for labelling on products produced by companies that pay certification fees;
- d. whether current schemes provide enough information for Australian consumers to make informed purchasing decisions;
- e. details regarding certification fees paid by food producers and/or manufacturers, and the potential for these to impact on prices for consumers;
- f. the importance of food certification schemes in relation to export market access and returns to producers;
- g. the extent and adequacy of information available to the public about certifiers including, but not limited to, certification processes, fees and financial records; and any related matters.

Response to the terms of reference in point order:

- A. The extent of halal certification is hidden from consumers. Many producers no longer display HC logo, so consumers can not choose to support this Islamic tax, or not.
- B. Labelling MUST be required to clearly display the producers support for halal certification. If any of their products (export OR domestic) carry halal certification, this should be displayed, so consumers can choose to support the Islamic tax, or not. This includes parent companies of the brand if any of the profits (and costs) are shared to or from parent companies that pay halal certification, as these costs will be spread across all brands indirectly.
- C. There is no "need" for halal certification. Muslim groups have agreed that "certification" is not required. It was devised PURELY to raise funds to grow islam.
- D. Current labelling does NOT allow consumers to make an informed choice as to whether they wish to contribute to the growth of islam in Western nations, including Australia.
- E. Producers are forced to sign non disclosure agreements to hide the fees paid, which are charged according to the producers "ability to pay", not on any other basis.
- F. Halal certification is not important to exports. Producers have been deceived. The halal certification scheme was developed purely to tax westerners to fund Islam.
- G. Information is not forthcoming from producers that support halal certification. Many are deceiving consumers for fear of the boycotting movement, which will increase with exposure to the scam. The damage to Australia's productivity through this deceptive religious tax will continue until it is banned. The Australian Government MUST BAN FEE COLLECTION for halal certification. Allow producers to certify if they choose, but require that their support for halal certification is CLEARLY

shown on all labels of their brands, domestic or export. The "necessity" for halal certification will then be shown for what it is – not necessary.

Conclusion for committee consideration:

Committee members should spend some considerable time to become familiar with Islam and the Koran. Halal certification was developed purely to extract funds from non Islamic Westerners, to fund the growth and promotion of Islam. Islam is a death cult. Islam preaches death to non believers, and practices many barbaric and unacceptable ideologies that contradict modern civilised law. The only intention of Islam is to dominate the world, and the halal certification rort is funding that cause.
