Attachment D: The full terms of reference from the Cole Royal Commission, again addressing a query from Senator Back. As indicated in our oral answer, this shows the referral of any individual matters for prosecution was incidental to, and only one element of, the wider terms of reference for the Royal Commission.

We are also examining the following further questions with a view to further assistance we may be able to provide to the Committee after examining the draft Hansard, and some further research and consideration:

- Senator Back's question regarding industrial claims for employers to pay income protection insurance.
- Senator Cameron's question regarding labour versus capital based productivity in the resources industry.
- Senator Cameron's final question regarding supervision of investigations under the existing legislation and the proposed approach in the *Building and Construction Industry (Improving Productivity) Bill 2013*.

We will also review the submission from Professor Peetz (Submission 8), and consider whether we can further assist the Chair and others who raised it with us.

We thank the Committee again for the opportunity to participate in this inquiry.
