Senate Select Committee on the Multi-Jurisdictional Management and Execution of the Murray Darling Basin Plan

Final Report tabled in the Senate

Issued: 30 September 2021

The Senate Select Committee on the Multi-Jurisdictional Management and Execution of the Murray Darling Basin Plan today presented its report to the Senate.

Tasked with identifying ways in which the multijurisdictional management and implementation of the Basin Plan might be improved, the committee has, since July 2019, received 62 submissions from individuals and organisations, and conducted 13 public hearings and four site visits across the basin.

The committee's report examines the complexities of federalism, water management and issues relating to transparency, compliance, environmental watering, Indigenous basin communities, SDLAM, and strategic water management.

The report makes 18 recommendations, largely focused on improving transparency and basin community engagement. These include:

- clarifying and streamlining governance responsibilities, decision-making, and interactions between Commonwealth and the basin state agencies;
- commissioning an independent basin-wide audit to identify whether the systems and processes associated with water accounts currently provide a comprehensive view of the system;
- adopting a best-practice, principles-based approach to communicating with key stakeholders, particularly Indigenous basin communities;
- improving representation of, and engagement with all impacted stakeholders in WRP development approaches;
- broadening expertise and capacity at the MDBA to ensure basin states are complying with and prioritising their Indigenous commitments;
- improving communication practices when providing objectives for, and reasons behind environmental watering;
- reviewing evaluation mechanisms for environmental watering to ensure they are accessible and appropriate;
- reviewing current research initiatives to ensure a longterm, and coordinated approach is in place to overcome major water-related challenges.
