I AM WRITING THIS BRIEF E MAIL IN WHICH I WOULD LIKE TO BE EXCLUDED FROM THIS FUTURE LEGISLATION WHICH WOULD ONLY GIVE MYSELF 4 WEEKS PORTABILITY A YEAR.... MY NAME IS KENNETH COLE, I HAVE BEEN ON A DSP SINCE 2007, [REDACTED] ..IN 2010 I WAS GIVEN THE RIGHT TO REMAIN IN INDONESIA, I WAS MARRIED AND HAD A CHILD, [REDACTED] WHO TURNS 4 YEARS IN NOVEMBER 2014..I WAS UNSUCCESSFUL IN MY PLEA TO REMAIN WITH MY WIFE AND CHILD, WHO I MUST NOW SUPPORT FROM AUSTRALIA, I GET TO RETURN FOR 8 WEEKS TO DO MY IMMIGRATION PAPERS WHICH UNDER INDONESIAN LAW MUST BE ABIDED BY OR I RISK IMPRISONMENT AND FUTURE DEPORTATION ORDERS FOR 5 YEARS, I LOVE MY SON AND HE DOES NT UNDERSTAND WHY DADDY DOES NT STAY WITH HIM, HE ASKS HIS MOTHER, DOES NT DADDY LOVE ME ANYMORE, THIS 4 WEEK LEGISLATIOIN WOULD DESTROY MY SON, PLEASE IMAGINE BEEN TOLD YOU COULD RESIDE IN A COUNTRY..( I HAVE THE ORIGINAL PAPERS FROM CENTRELK, WHICH IN COURT THEY DENIED THEY EXIST, I DO HAVE THEM) HOWEVER THE LEGISLATION CHANGED IN 2011 AND I LOST ALL THREE CASES WITH THE AAT, PLEASE FACTOR IN THE HUMAN SIDE OF THIS CASE, I MISS MY WIFE AND SON SO MUCH, WOULD YOU DO THIS TO YOUR OWN FAMILY AND SON, I BEG YOU TO CONSIDER MY CASE AND MY PLEA TO BE WITH MY WIFE AND SON..

WHEN I WAS GIVEN THE RIGHT TO STAY IN INDONESIA I WAS ON REDUCED BENEFITS, NO ACCESS TO MEDICINES, RENT ASSISTANCE ETC WHICH I UNDERSTOOD AND AGREED TO..I WITH MY WIFE LIVE IN EAST JAVA WITH HER AILING MOTHER, IM NOT LIVING THE LIFE OF RILEY IN BALI OR SOMEWHERE..PLEASE UNDERSTAND, I AM 55 YEARS OLD , I WAITED A LONG TIME TO HAVE A PRECIOUS GIFT OF A CHILD, TRY TO IMAGINE LOSING A CHILD BY ANY MEANS..
