Driving –Medicinal Marijuana has not shown increase of road accidents as some people against have said that it would. It should be treated like any other Medicine – a warning on the packaging, do not drive or operate heavy machinery.

Schizophrenia – Those against Medical marijuana always bring up cannabis as causing or bring on schizophrenia in pre disposed cases. There has been no increase in schizophrenia in areas where medical marijuana or recreational marijuana has been legalized it has remained at 1% of the population.

Misuse- There will always be people who sell prescribed drugs on the black market. I know of a huge portion of ADD an ADHD sufferers who ham it up to have their prescriptions increased just to sell a bottle or two of Dexamphetamine off.

Cannabis and Youth – There has always been that risk of restricted products getting in the hands of the youth.
