Tasmania's unique biodiversity

The House Committee on Climate Change, Environment and the Arts is visiting Tasmania as part of its inquiry into Australia's biodiversity in a changing climate.

The inquiry is examining biodiversity and climate change in relation to nationally important ecosystems, with particular regard to terrestrial, marine and freshwater ecosystems; the role of connectivity between ecosystems; impacts on human communities; and strategies for adaptation, sustainable resource use, and enhancing community engagement.

During its visit to Tasmania, the Committee will visit sites where restorative projects are being undertaken to protect biodiverse ecosystems in response to the challenges of climate change. The Committee will also hold a public hearing in Hobart.

The Committee Chair, Mr Tony Zappia MP, said 'the Tasmanian Wilderness is a World Heritage listed area. Tasmania has an unusually high proportion of endemic species, and its fauna is of world importance. And with geographic features quite distinct from those of the mainland, managing Tasmania's biodiversity in a changing climate will provide local researchers, policy-makers and land managers with some unique challenges and opportunities. The Committee is looking forward to learning about some of the projects and strategies that are being put in place in Tasmania in response to these challenges.'
