The House of Representatives Standing Committee on Education and Employment Inquiry into the role of Technical and Further education system and operation

As a visual art lecturer at the Margaret River TAFE I am making a submission that outlines the significant contributions our course makes to the arts industry and wider community. I am concerned that the increasing cuts to TAFE budgets will reflect negatively on the course and impede its potential for growth.

## The development of skills in the Australian economy

The Shire of Augusta Margaret River is a renowned tourist destination that has a thriving and growing tourism industry. The arts make a significant contribution to the local economy and play an important role in enhancing the cultural experience for visitors and residents in the region. ## The development of opportunities for Australians to improve themselves and increase their life and employment prospects

The Visual Arts course at the Margaret River Education Campus serves the community by allowing people of all ages to gain skills and refresh skills that will enable them to lead more fulfilling lives. Many people who join the classes gain knowledge about the arts that feeds directly into the economy and culture of the community. Funding also needs to be sufficient to grow the arts course and to purchase additional equipment when necessary. Cuts have been made within the course I deliver;

- reduced teaching hours
- No professional development
- No colour photocopying for student hand-outs

My concerns are that the increasing cuts to TAFE budgets will reflect negatively on the Visual Arts Course at the Margaret River Education Campus and impede its potential for growth.
