THE COMMITTEE HAS TO INVESTIGATE OR ENQUIRE ABOUT THE PROCESSES APPLIED BY THE MEDICAL /APRHA AGAINST FOREIGN DOCTORS WORKING IN AUSTRALIA

A)REGARDING THE SCI:

- 1)WHY WAS A SCI IMPOSED? SUCH A DRACONIAN /"MARTIAL LAW"/"KANGAROO COURT" ASSESSMENT APPLIED?
- 2) WHY WERE THE DOCTORS NOT GIVEN ADEQUATE KNWOLEDGE WHAT WAS BEING TESTED AND THE IMPLICATIONS?
- 3)WHY WAS THIS SCI NOT VIDEO /AUDIO RECORDED , TO MAKE IT FAIR FOR ALL CONCERNED ?
- 4) HOW MANY DOCTORS FAILED THE SCI?
- 5)HOW MANY OF THESE HAD TO LEAVE AUSTRALIA WITHIN 28 DAYS AS RESULT? THE COMMITTEE SHOULD ADDRESS THIS AS MANY OF THESE DOCTORS HAVE DEDICATED MANY YEARS IN SERVICE TO AUSTRALIAN PUBLIC AND THEY HAD THEIR FAMILIES HERE, AND HAD ASPIRATIONS OF LIVING IN AUSTRALIA. THIS IS NOT INKEEPING WITH THE ETHOS OF FAIRNESS.
- 6) WHAT ARE THE STATISTICS OF THE NUMBER OF DOCTORS WHO HAVE FAILED BEFORE SEPTEMBER AND AFTER?
- 7)WHY WAS ACCRM ALLOWED TO CONTINUE WITH THE SCI WHEN THEY HAVE ACKNOWLEDGED FLAWS AND ARE FORMING A NEW ASSESSMENT?SHOULDN'T THE SCI HAVE BEEN STOPPED IMMEDIATELY! (IT STILL CONTINUE)

B) THE FOUR YEAR TIMETABLE WOULD BE UP THIS YEAR FOR FULL REGISTRATION OF MORETHAN 300 FOREIGN DOCTORS WORKING IN AREAS OF NEED, WILL BE DEREGISTERED AND WOULD HAVE TO LEAVE .WOULDTHE PARLIMENTARY COMMITTEE BE ABLE TO SAVE THESE DOCTORS FROM THIS .

THE COMMITTEE CAN HELP BY STOPPING HAEMORRHAGE AND QUESTIONING THE FAIRNESS

ALL FOREIGN DOCTORS KNOW THEY HAVE TO BE FULLY REGISTERED AND HAVE NO PROBLEM GOING THROUGH TRIED AND TESTED EXAMS IN ACQUIRING THEIR REGISTRATION .THE CONCENSUS IS THAT THE DOCTORS REQUIRE MORE TIME AND FAIRER ASSESSMENT PROCESSES.THEY SHOULD BE BE GIVEN A FAIR CHANCE RATHER THAN BEING TREATED AS COMMODITIES NO LONGER NEEDED.

I WOULD APPRECIATE IT IF THE COMMITTEE WILL ADDRESS THESE TWO ISSUES PLEASE.
