Northern Australia Committee begins its inspection/public hearing tour

The Australian Parliament's Northern Australia Committee will next week begin six weeks of inspections and public hearings across the breadth of Northern Australia. In the week beginning 31 March, the Committee will visit Mackay, Bowen, Ayr, Townsville and Mt Isa in Queensland's north.

Committee Chair, the Hon. Warren Entsch stated: "This is an important phase of the inquiry when the Committee visits existing and potential projects and talks to local people and organisations about their vision for developing northern Australia."

The Committee will conduct five public hearings, receiving evidence from more than 35 organisations and individuals and inspecting a number of projects between Mackay, Townsville and near Mt Isa.

"Northern Australia has great potential to boost Australia's economic development and significantly contribute to our exports," Mr Entsch said. "The Committee will be seeking to identify ways to unlock this potential as well as identifying key projects of merit."
