Employment minimum age Convention under examination

Federal Parliament's Treaties Committee will be holding a public hearing on Monday, 13 May 2013, to examine an International Labour Organization (ILO) Convention concerning the minimum age for admission to employment.

The Convention aims to ensure the effective abolition of child labour and to set the minimum age for admission to employment.

"In Australia, the minimum age for admission to employment is generally determined by compulsory education legislation, and the State and Territory governments have advised that their jurisdictions already comply with this Convention" Committee Chair, The Hon Richard Marles MP, said. "The Government believes that formal ratification of this treaty would enhance Australia's standing in the international community and the ability to address labour rights issues, particularly within our region. The Committee will be examining how this is to be achieved, and if is there are other likely impacts of ratification for Australia."
