Review of Treaty of Amity and Cooperation in Southeast Asia

The Joint Standing Committee on Treaties, chaired by Mrs Margaret May MP, will hold a public hearing on Monday 12 September to examine the Treaty on Amity and Cooperation in Southeast Asia.

Signing up to the Treaty will allow Australia to participate in the East Asia Summit which was established in November 2004 by ASEAN States in addition to Japan, Korea and China. The Summit is expected to canvass a range of economic and political issues relevant to the region.

"Australia already fulfils two of the three criteria necessary for full participation in the East Asia Summit," Mrs May said.

"The third criterion requires being a signatory to the *Treaty of Amity and Cooperation in Southeast Asia*. The Committee will review the treaty and examine the benefits or otherwise of signing onto the treaty.

'It is important that this Treaty does not affect our existing treaty commitments including ANZUS and the Five Power Defence Arrangements. Foreign Minister Alexander Downer articulated this in his letter of 13 July 2005."

The public hearing will be held in Committee Room 2R1, Parliament House, Canberra on Monday, 12 September 2005 from 10.00 am. A public hearing program is attached.
