Immigration detention from a human rights perspective

Migration Committee Chair Michael Danby has announced that the Australian Human Rights Commission (formerly HREOC) will be among the organisations appearing at a public hearing in Sydney tomorrow (24 October) as part of the inquiry into immigration detention in Australia.

Human Rights Commissioner Graeme Innes has welcomed the changes to immigration detention announced by the Minister for Immigration and Citizenship earlier this year, claiming they reflect 'a fundamental shift' in policy.

Under these reforms, people will be held in detention until health, security and identity checks have been completed.

Beyond this, mandatory detention will continue to apply to those people that present an unacceptable risk to the community and to unlawful non-citizens who have repeatedly refused to comply with their visa conditions.

In the Commission's submission to the inquiry, however, it says that, 'HREOC has not received further detail on the practical implementation of the new approach, in particular how such changes will be enforced or guaranteed'.

'We are concerned that without legislative change these intentions may not be sufficient to create a system that guarantees freedom from arbitrary detention, among other human rights'.

Chair Michael Danby acknowledged the Commission's substantial engagement in the area of human rights and detention. 'The Commission has conducted a number of investigations into immigration detention in accordance with its charter and often their recommendations have been unpalatable to government', he said.

'But these questions about improvements to the system and the best way to implement those are precisely what the Committee will be interested in discussing in Sydney', said Mr Danby.

'We look forward to hearing the views of the Human Rights Commission and others'.

Other witnesses at the hearing will include National Legal Aid, the Asylum Seekers Centre of NSW, the Asylum Seekers Resource Centre of Melbourne, GetUp and former Human Rights Commissioner Dr Sev Ozdowski, who produced HREOC's influential 2004 report on children in immigration detention.
