Dear Senator Lundy

I would like to bring to the Committee's attention points of correction in regard to evidence provided to the Inquiry by Mr Jim Paterson and Mr John Williams appearing for the Canberra Region Tourism Operators Association (CRTOA) on 23 April 2008.

During evidence, Mr Jim Paterson raised the issue of the Westminster Chimes at the National Carillon not being switched on following recitals. A National Capital Authority e-mail response to Mr Paterson on 11 January 2008 (attached), stated that the Westminsters are turned off during recitals, when functions are being held in the Chimes Function room, when the carillionists are practicing and when maintenance is being performed on the bells and other areas of the Carillon. The e-mail also apologised for any disappointment caused to his customers as a result of the Westminsters being turned off.

Mr Paterson also claimed that the May meeting of the Lake Users Group was postponed indefinitely. The meeting was postponed however I am advised that the Group, of which Mr Paterson is a member, was informed that they would be advised of the new meeting date as soon as possible. The date for the next meeting has been confirmed for 4 June 2008.

Mr Paterson and Mr John Williams made a number of comments in regards to the opening hours of the National Capital Exhibition. The new opening hours have been posted on the NCA website since 23 February 2008 when the changes came into effect. Briefings were held for Australian Capital Tourism (22 January 2008) and the National Capital Attractions Association (6 February 2008) of which CRTOA is a member. I understand Mr Williams was not present during that briefing however I am advised that another CRTOA member was present.
