

Re: FIFO Workforce practices

Thank you for the opportunity of providing a supplementary submission to your inquiry and I attach population decline figures for the West Coast of Tasmania.

As you are aware the evidence I gave factually describes the demise and loss of social and financial responsibility of mining communities to the West Coast of Tasmania by resource industries.

For many years the mining companies built towns, supplied housing, health and sporting requirements and supported many clubs and organizations that were assisted to form within these towns. The mines even supplied electricity to some communities, most of this support is now diminished or non-existent.

I believe our proposal for a \$10k zone taxation benefit would assist to reverse population decline and should be trialed as a pilot scheme for 5 - 10 years. State and Federal Governments failure to do anything could result in a social, economic, welfare and volunteer problems.

Note: The Tasmanian State Government will collect over \$50 million in mining royalties this year.



Western end's population decreases by 26 people

Eastern end proves popular

THE region's population is continuing to tilt towards the eastern end of the Coast.

Between them, the Devonport, Central Coast, Latrobe and Kentish municipalities gained 332 people between June 2010 and June 2011, according to the Australian Bureau of Statistics.

At the same time, the western end councils (Burnie, Waratah-Wynyard, Circular Head, West Coast and King Island) lost 26 people in total.

That left roughly four people on the eastern end for every three on the western end, with a total eastern end population of 64,502 and western end population of 49,648.

The divergence would population to 511,195. have been even bigger but for a strong performance by Burnie, which gained 126 people.

The West Coast shed 158. and that was before the Fossev Mine closure. which can't have helped West Coast population.

King Island also went backwards, while Circular Head and Waratah-Wynyard had minor growth.

As has come to be expected, Latrobe was the shining light on the eastern end, gaining a region's best 209 people.

The region's two most populous municipalities, Devonport and Central Coast, gained 77 and 69 residents respectively, according to the ABS estimates.

Kentish went backwards slightly.

The region overall gained 306 people for the year and the state 2988, taking state

The ABS said Tasmania's population grew by about 39.400 people in the decade ending in June 2011.

That 8.4% growth was the nation's lowest, equal to South Australia.

Tasmania was the only state in the decade where population grew by more outside the greater capital city area than in it; 21,400 to 18,000.

Tasmania also had a bigger proportion of residents (58%) living outside the greater capital than any other state or territory.


Port Sorell was the region's fastest growing area of the decade, gaining about 1200 people.

The Parklands-Camdale area in Burnie gained 950 and the Sheffield-Railton area about 900.

The West Coast lost about 610 people for the decade.












LAND USE
