PARLIAMENTARY STANDING COMMITTEE ON PUBLIC WORKS

FORTY-FIRST GENERAL REPORT

Pursuant to Section 16 of the Public Works Committee Act 1969, the Parliamentary Standing Committee on Public Works has the honour to report the proceedings of the Committee during the period 1 January to 10 November 1977.

TWENTY-FOURTH COMMITTEE

1. Members of the Twenty-fourth Committee were appointed in the Senate on 4 March 1976 and in the House of Representatives on 3 March 1976. They were Senator B.F. Kilgariff, Senator J.I. Melzer, Senator H.W. Young, Messrs. M.H. Bungay, A.W. James, L.K. Johnson, the Honourable C.R. Kelly, Messrs. J.L. McMahon and P.C. Miller. At the first meeting of the Committee on 16 March 1976, the Honourable C.R. Kelly was elected Chairman and Mr. L.K. Johnson, Vice-Chairman.

PROPOSALS REFERRED TO THE COMMITTEE

2. The Committee presented eleven reports to Parliament during 1977; three related to proposals referred in November and December 1976 and the remaining eight were in response to references of work to the Committee during 1977. One proposal, referred early in October 1977, could not be examined and reported on due to the dissolution of Parliament on 10 November 1977. Details of these references and reports may be found in a tabulated summary at Appendix A.

MEETINGS

3. The Committee met on 34 occasions during 1977. These meetings were held to take evidence at public hearings, carry out inspections and to undertake private deliberations and took place in Canberra (12), Alice Springs (2), Katherine (2), Darwin (1), Point Cook (1), Sydney (4),

Blacktown (2), Melbourne (1), Kingston, Tasmania (1), Edinburgh, S.A. (2), Hobart (2), Rockhampton (3) and Glenbrook, N.S.W. (1).

PROPOSALS REPORTED ON BY THE
PUBLIC WORKS COMMITTEE 1972 - 1976

4. At Appendix B is a tabulated summary of progress to date of all works reported on by the Committee from January 1972 to December 1976. This information was originally provided in the 40th General Report and has been updated. The Committee believes that this review of the relative progress of jobs to original planned targets is useful information and should continue in all future General Reports to Parliament.
5. The Committee is aware that the Department of Construction and its client Department, in making a presentation at a public hearing, attempt to indicate the shortest possible time frame for contract documentation and construction of proposed work. We are also aware that following on consideration of our report by Parliament, subsequent development of each project and its eventual progress to construction is mainly a budgetary consideration and hence is a matter of Government decision.

INTERDEPARTMENTAL COMMITTEE REPORT ON THE
PUBLIC WORKS COMMITTEE ACT (PARLIAMENTARY PAPER NO. 105/74)

6. The Committee has been advised that this report, aimed at widening the ambit of the Public Works Committee to include statutory authorities, is still under consideration by the Government.

OVERSEAS BUILDINGS

7. In our Thirty-ninth General Report, we drew attention to the magnitude of the Department of Foreign Affairs then current overseas design and construction program of over \$86 million as disclosed in the 1974 annual report of that Department. The Committee at that time noted that this expenditure does not come within the ambit of the Public Works Committee and requested that this anomaly be considered by the Government. We understand that this matter is under consideration as an item for decision as part of the proposed amendment of the Public Works Committee Act to incorporate the works proposals of statutory authorities.

JOINT COMMITTEE ON THE PARLIAMENTARY COMMITTEE SYSTEM

8. The report of this Committee is also still under consideration by the Government. The report, inter alia, recommends the abolition of the Public Works Committee in its present form. As stated in the Fortieth General Report, the Committee rejects this recommendation.

CAR PARKING

9. In its Thirty-ninth General Report, the Committee drew attention to the need for a re-examination of the policy regarding the provision of car parking space at major Commonwealth Government establishments with a view to establishing some consistency throughout Australia. The Committee has noted the following information provided by the Government in respect of the provision of car parking. As a general rule, parking facilities at Commonwealth properties are only provided for official/operational vehicles, customer vehicles, vehicles belonging to disabled persons and vehicles used regularly for official purposes. These requirements are initially estimated by the Client Department/Commissioner requiring the facility. The extent to which on-site car parking can be provided is dependent on any one or a combination of factors including the activities of the Client Department, the availability of public transport, the requirements or attitudes of the State or Local Authority concerned, the space available on the site and the expense of providing such parking space without incurring excessive cost.

10. The foregoing factors naturally vary from project to project and on whether the building is to be built in the inner city, suburban or country area. It is a case, therefore, of each individual project and site being considered on its merits. As such, this is the policy of the Commonwealth relating to car parking for private vehicles.

WIDER USE OF CARPETS

11. In the Fortieth General Report, we referred to the opinion that has been expressed to us on a number of occasions by the Department of Construction that carpet is the more economical type of floor covering when cleaning and other costs are taken into consideration and that we were "at a loss to understand why a policy decision on the wider use of carpet is taking so long to resolve". We have now been informed that "due to pressures in

other areas" the Department of Construction has not been pressing the matter and that "there has been virtually no progress at all over the past year", and that "In the interim each and every case for the use of carpet is treated in isolation".

12. We have been advised that the matter will be raised again with the inter-departmental committee "in the near future to achieve a final decision".

WORKS EXCEEDING PUBLIC WORKS COMMITTEE REFERENCE LIMIT
OF \$2 MILLION DURING DOCUMENTATION/TENDERING STAGE

13. During debate in the House of Representatives in 1974, on an amendment to the Public Works Committee Act to include a definition of the term "estimated cost", it was suggested that the Committee should include in the General Report details of those works which exceeded the mandatory reference figure of \$2 million during documentation/tendering and which would therefore escape Public Works Committee scrutiny.

14. During the year ending 31 December 1977 there were no projects which at the Limit of Cost estimate stage were below \$2 million and subsequently exceeded \$2 million due to cost increases.

15. Inflation in building costs in 1977 was generally lower than in previous years. This had a direct bearing on the number of jobs which fall within the category of escalating above the \$2 million limit.

APPRECIATION

16. The Committee pays tribute to its retiring Chairman, the Honourable C.R. Kelly for his untiring efforts and dedication, particularly during his two terms as Chairman from 26 November 1969 to 2 November 1972 and from 3 March 1976 to 10 November 1977.

17. The Committee also wishes to record its appreciation to all those who gave assistance at public hearings and site inspections, particularly officers from the Department of Construction.

18. We are also appreciative of the work done by the Principal Parliamentary Reporter and his staff in recording our proceedings.
