

TERMS OF REFERENCE

In October and November 1987, the Senate and the House of Representatives passed resolutions referring the following matter to their respective Standing Committees on Transport, Communications and Infrastructure for inquiry and report:

All notices of intention to modify or vary the plan of layout of the City of Canberra and its environs and all modifications and variations of that plan under section 12A of the Seat of Government (Administration Act 1910). (Journals of the Senate, No. 18 dated 26 October, 1987).

That all proposals for modification variations of the plan of layout of City of Canberra and its environs published in the Commonwealth of Australia Gazette on 19 1925, as previously modified or November varied, be referred to the Standing Committee Infrastructure and, when conferring with a similar committee of the Senate, the committee shall inquire into and report on all such (Votes and Proceedings, No. 20 proposals. dated 2 November 1987).

The resolutions also empowered the Committees to sit as a Joint Sub-Committee to consider the matter referred to above.

INTRODUCTION

- 1. Section 12 of the <u>Seat of Government (Administration)</u>
 <u>Act 1910</u> deals with variations to the plan of the City of Canberra.
- 2. The Minister may, at any time, modify or vary the plan. A variation cannot be made until twelve days after a notice of intention has been published in the Commonwealth of Australia Gazette.
- 3. In practice, the Minister does not vary the plan until the variation and public comment on the variation have been considered and reported on by the Joint Sub-Committee. The ACT Administration advertises the variation, collates public comments and objections and provides the Sub-Committee with briefing materials. Since the 30th Parliament, public hearings have been held to consider proposals to vary the plan. A report approving or rejecting the variation is then tabled in the Parliament.
- 4. When the variation is signed by the Minister, it must be laid before each House of the Parliament within 15 sitting days of that House. The variation ceases to have effect, if either House of Parliament passes a resolution disallowing the variation. Notice of such a resolution must be given within six sitting days of the variation being laid before that House.
- 5. This report, the second by the Joint Sub-Committee, deals with the following variation to the plan of layout of the City of Canberra and its environs:

Variation 1988/3 (containing one proposal)

- 6. The Joint Sub-Committee, in keeping with the practice of the former Joint Committee on the Australian Capital Territory held a public hearing on Variation 1988/3 on 7 October Officers of the ACT Administration and the National Capital Development Commission (NCDC) gave evidence at the hearing. The witnesses who appeared before the Sub-Committee are listed in Appendix 1. Members of the Joint Sub-Committee inspected the site of the proposed Variation prior to the public hearing.
- 7. The ACT Administration and the NCDC prepared briefing notes on the proposal contained in the variation. The briefing notes for Variation 1988/3, appear at Appendix 2. The briefing notes provide details of the variation including purpose, cost, existing and proposed development and the extent of community consultation. The Committee's report should therefore be read in conjunction with the briefing notes and the transcript of evidence.

VARIATION 1988/3

Background

- 8. In the <u>Commonwealth of Australia Gazette</u> of 26 August 1988, the Minister for the Arts and Territories, pursuant to the powers conferred on him by section 12A of the <u>Seat of Government (Administration) Act 1910</u> notified his intention to vary the plan of layout of the City of Canberra and its environs. Variation 1988/3 relates to Greenway: Sections 8 and 10 Road Additions.
- 9. The notice of intention to vary the City Plan also invited members of the public to lodge objections to the proposed variation with the Secretary and Manager of the NCDC within twelve days of its publication. The ACT Administration displayed the intended variation at its offices in Civic, the Tuggeranong Hyperdome and at the NCDC offices in Braddon. The ACT Administration advertised the variation in The Canberra Times on 3 September 1988 and 7 September 1988 and issued a press release on 30 August 1988.
- 10. Two objections were lodged with the Secretary and Manager of the NCDC. In one objection the question was raised about the lack of an explanatory statement in the newspaper advertisements identifying the nature and locality of the proposed variation. As a result, the ACT Administration readvertised the variation in The Canberra Times on 17 September 1988 with the explanatory statement and the period for lodgement of submissions was extended to 23 September, 1988. The other objection did not relate to the proposed variation and the objector was notified.
- 11. On 29 August, 1988 the Assistant Secretary, Lands, Office of Industry & Development, ACT Administration, referred the proposed variation to the Joint Sub-Committee for inquiry and report.

Public Hearing

- 12. At the public hearing held on 7 October, 1988 officers of the NCDC and the ACT Administration briefed the Joint Sub-Committee on the proposal. Variation 1988/3 provides for a road and four service lanes in the Tuggeranong Town Centre Service Trades Area to facilitate the progressive release of development sites in this area. The roads and service lanes will access approximately 12.5 hectares for service trades and motor vehicle servicing and repair uses. The cost to the Commonwealth for the construction of the roads and services in the Trades Area is estimated to total \$3.0 million.
- 13. The Joint Sub-Committee is concerned to ensure that there is no intrusion of the proposed roads into the areas of footpath and cycle access and foreshore landscaping. The NCDC and ACT Administration advised that such encroachment would not happen.

Recommendation

14. The Joint Sub-Committee approves Variation 1988/3.

GREENWAY: SECTIONS 8 AND 10 - ROAD ADDITIONS

I. Purpose

To gazette a road and four service lanes in the Tuggeranong Town Centre Service Trades Area to facilitate the progressive release of development sites in this area.

2. Background

The first stage of the infrastructure works for Tuggeranong Town Centre commenced in November 1985. The roads, carparks and services for the core area are now largely complete and a number of major developments such as the Hyperdome, Homeworld and Health Insurance Commission office complex are open or nearly finished. Planning and development work for the other parts of the town centre has continued with a view to satisfy the demand for the full range of town centre uses including service trades.

3. Area

The roads and service lanes will access approximately 12.5 hectares for service trades and motor vehicle servicing and repair uses.

4. Estimated Cost

The cost to the Commonwealth for the construction of the roads and services in the Trades Area is estimated to total \$3.0m.

5. Existing Development

Reed Street, on the northern edge of the Trades Area, is constructed and Scollay Street to the west is built to approximately 100 metres south of its intersection with Reed Street.

6. Future Development

The Trades Area has capacity for a total of approximately 50,000m² of service trades and motor vehicle servicing and repair uses. It is proposed to release sites in this area progressively from late 1988 and over the next 5 to 10 years depending on demand.

7. Particular Planning Considerations


The Trades Area has been designed in accordance with the key principles for the planning of Tuggeranong Town Centre namely the provision of an urban structure that is simple, legible and efficient. The service trades uses flank Anketell Street reinforcing its status as the "main street" of the town centre, and ensuring a high standard of vehicular and pedestrian access between the Trades Area and the town centre The provision of ample convenient carparking, the simple arrangement of the buildings around the carparks and the provision, where possible, of segregated service access are features of the design of the service trades development. It is proposed to continue the architectural controls which are contributing to a distinctive and unified appearance in the town centre buildings.


8. Environmental Considerations

As with all town centre developments, particular attention has been paid in the planning of the Trades Area to Environmental quality. All run-off from the Trades Area will be directed to the upper reaches of Lake Tuggeranong to ensure that the water quality in the Murrumbidgee River and the main body of the lake is of a suitably high standard.

9. Public Consultation

The Tuggeranong Town Centre Policy Plan Development Plan report published in November 1986 indicates the general location of the Trades Area in the town centre. No other public consultation has been undertaken except that inherent in the gazettal process.

I refer to the advertisement on page 35 of today's Canberra Times about variation 1988/3 to the City Plan.

I wish to lodge objection in principle to the proposals and, if necessary, specifically to all proposals.

My objections are to the process and the way in which the ACT Administration is dealing with these calls for comment. I have noticed that on two occasions the closing date for comments and objections is two days after the notice first appears in the Canberra Times. No information is given about the nature or locality of the changes being proposed. I do not have time to get to the NCDC building, inspect the plans said to be there, decide what it all means and whether I have any objections and comments to make, make a written submission about the matter and lodge by 4.30 pm on 9 September. I doubt that many residents could achieve such a timetable even if they knew what was being proposed and knew they had an objection or comment. If you were reliant on public transport you would have no hope of meeting such a timetable.

Most residents do not receive the Gazette and even public servants, who might have access to it through work, would need to be vigilant to spot such notices.

If the ACT Administration, and the NCDC, is sincere in inviting public comment and objections then it should be a little more open. Such notices when they came from the NCDC used to give a very brief description of the area and nature of the change eg Isabella Plains, Brown Street - widen roadway. Then a resident can form some idea of whether he/she has an interest in the matter and wishes to take the effort of going to the NCDC to inspect the plan.

Secondly, adequate time should be given for this. Surely to allow 14 days is not excessive.

Thirdly, the plan should be more widely available. For example in public libraries or shopping malls. Somewhere where people can see it without needing to make journeys out of their way. How many people have cause and time to go to the NCDC offices, which are only open in business hours during the week?

To cover the possibility that my concern is not of a nature which you or the Joint Sub Committee can act on, I wish this letter to serve as an obligation to all proposals to vary the City Plan while the present administrative arrangements remain.

The last time such a notice appeared in the Canberra Times I noted it with concern but pressures at work prevented me from reacting within the 48 hours. For this reason, I am acting this time, although in more haste than I would wish, to record my concern.

I feel sure that administrative arrangements which give residents a reasonable chance of assessing their attitudes and responding are possible and within a time frame which does not unduly delay the process of change.

I refer to your letter of 8 September 1988 concerning the 1988/3 Series of Variations to the City Plan.
