Please find attached the Winemakers' Federation of Australia (WFA) calculation for the estimated benefit of A\$20-\$A25m (to the Australian wine industry) arising from the AU/US Free Trade Agreement (FTA).

The benefit (value) to the Australian wine industry of the AU/US FTA in 2015 (ie all US import tariffs on wine reduced to zero) is ~A\$44m. Utilising a conservative approach, if half the benefit is apportioned to US importers/distributors (as assumed by WFA), then the benefit to the Australian wine industry is ~A\$22m.

Calculation assumptions:

- Australian wine export volume proportions to the US (based on December 2003 MAT data) remain constant ie. red/white/sparkling, bottle/bulk/soft pack etc
- Australian wine export volume to the US Compound Annual Growth Rate of 12.83% 2002-2010
- Australian wine export volume to the US CAGR of 5.00% 2010-2015

(note: the 1996-2002 CAGR of Australian wine export volume to the US is ~33%)

- tariff rates as per the Harmonized Tariff Schedule of the United States (2004)
- 80% of bottle red table wine exports to the US is below 14% alcohol volume
- constant US\$:A\$ exchange rate US\$1 = A\$0.7313
