- 2. Message from the Senate.—Consolidated Revenue Bill (No. 2).—Mr. Speaker announced the receipt of the following Message from the Senate:-

Mr. Speaker,

The Senate has agreed to the modification made by the House of Representatives in suggestion No. 2 of the Senate in the Bill intituled "An Act to apply out of the Consolidated Revenue Fund the sum of Four hundred and ninety-one thousand eight hundred and eighty-two pounds to the service of the period ending the thirtieth day of June One thousand nine hundred
