- 1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Petitions.—Mr. Tudor presented a Petition from certain firms and dressmakers, praying that the McDowell Garment Drafting Template be admitted into the Commonwealth free of duty as a tool of trade.
 - Petitions, as follow, were presented by Sir John Forrest against the increased duties on machinery, railway and tramway material, and praying that the import duties, so far as Western Australia is concerned, should be reconsidered, with a view of arranging a basis of taxation which will foster and protect mining and its allied interests and new industries which are for the public benefit; and also that any increase in duties under the Commonwealth Tariff as compared with rates previously existing shall be made inapplicable to contracts and engagements entered into prior to the date of such tariff coming into force, in the same way that His Majesty's Government has dealt with coal contracts entered into before the imposition of the export duty from the United Kingdom:—
