### TUESDAY, 22ND APRIL, 1902.

- 1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Petitions.—Mr. Barton presented a Petition (which had been deposited with the Clerk) from James. Crooke Whitelaw, of Zeehan, in the State of Tasmania, accountant and commission agent, against the return of William Hartnoll as a Member for Tasmania, and praying that it may be determined that the said William Hartnoll was not duly elected or returned, and that the said James Crooke Whitelaw was duly elected, and ought to have been returned.

Mr. Barton moved, That the Petition be received, and be referred at once to the Committee of Elections and Qualifications for inquiry and report.

Debate ensued.

Question—put and resolved in the affirmative.

Mr. Bamford presented a Petition from Kate McKillop and L. Alder, styling themselves respectively Secretary and President of the Women's Australian Natives Association, Queensland, and others, praying that the House will pass with the least possible delay the necessary legislation for giving women the franchise for both Houses of the Commonwealth Parliament, on the same terms as it is now or may hereafter be granted to men.

Petition received and read.

3. Customs Tariff Bill.—The Order of the Day for the resumption of the debate on the question,
That the Bill be now read a second time, having been read—

4. Excise Tariff Bill.—The Order of the Day for the second reading of this Bill having been read—Mr. Kingston moved, That the Bill be now read a second time.

Question—put and resolved in the affirmative.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Speaker resumed the Chair; Mr. Chanter reported that the Committee had gone through the Bill and agreed to the same without amendment.

On the motion of Mr. Kingston the House adopted the Report.

On the motion of Mr. Kingston the House ordered that the Standing Orders be suspended so as to allow the Bill to be read a third time this day.

Mr. Kingston moved, That the Bill be now read a third time.

Question—put and resolved in the affirmative.—Bill read a third time.

5. Adjournment. —Mr. Barton moved, That the House do now adjourn. Question—put and resolved in the affirmative.

And then the House, at thirty-seven minutes past nine o'clock p.m., adjourned until to-morrow, at half-past two o'clock p.m.
