- 1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Petition.—Mr. Hume Cook presented a Petition from John Robertson, of Moonee Ponds, praying that the House will inquire into the monetary law of the Commonwealth, and the desirability of its immediate reform. Petition received.
- 3. Message from His Excellency the Governor-General.—Bonuses for Manufactures Bill.— The following Message from His Excellency the Governor-General was presented by Mr. Kingston, and the same was read by Mr. Speaker:-

Governor-General.

Message No. 40.

In accordance with the requirements of section 56 of The Constitution of the Commonwealth of Australia the Governor-General recommends to the House of Representatives that an appropriation of revenue or moneys be made for the purposes of a Bill for an Act relating to Bonuses for the Encouragement of Manufactures.

- 4. GOVERNOR-GENERAL'S ESTABLISHMENT BILL.—The Order of the Day for the consideration in Committee of the whole House of His Excellency the Governor-General's Message No. 39 having been read-

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Speaker resumed the Chair; Mr. Chanter reported that the Committee had come to a certain

Ordered—That the Report be considered at once.

- Mr. Chanter reported from a Committee of the whole House the following resolution, which was read:—
 - Resolved-That it is expedient that an appropriation of moneys be made for the purpose of a Bill for an Act relating to the Governor-General's Establishment.

And the said resolution was adopted by the House.

- Ordered—That Mr. Barton and Mr. Deakin do prepare and bring in a Bill to carry out the foregoing resolution.
- 5. Governor-General's Establishment Bill.—Mr. Barton then brought up a Bill intituled "A Bill for an Act relating to the Governor-General's Establishment," and moved, That it be now read a

Question—put and resolved in the affirmative.—Bill read a first time.

Ordered—That the second reading be made an Order of the Day for to-morrow.

- 6. Supply.—The House, according to Order, resolved itself into the Committee of Supply. Mr. Speaker resumed the Chair; Mr. Chanter reported that the Committee had made progress, and that he was directed to ask, That the Committee may have leave to sit again. Resolved—That the House will, to-morrow, again resolve itself into the said Committee.
- 7. ADJOURNMENT. —Sir John Forrest moved, That the House do now adjourn. Question—put and resolved in the affirmative.

And then the House, at four minutes to eleven o'clock p.m., adjourned until to-morrow, at half-past two o'clock p.m.
