- 2. Message from His Excellency the Governor-General.—Assent to Bill.—The following Message from His Excellency the Governor-General was presented by Sir William Lyne, and the same was read by Mr. Speaker:—

A Bill intituled "An Act to provide for an Uniform Federal Franchise," as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name of His Majesty, assented to the said Act.

3. Bonuses for Manufactures Bill.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—and on the following amendment, viz.:—That all the words after the word "now" be omitted, and that the following words be inserted in place thereof, viz.:—"referred to a Select Committee to consider and report upon the advisability of establishing Commonwealth or State ironworks. That such Committee consist of the Minister of Trade and Customs, Mr. Batchelor, Mr. R. Edwards, Mr. Fuller, Mr. Hughes, Mr. Kirwan, Mr. Mauger, Mr. Thomson, and the Mover"—
