- 1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Paper.—Mr. Kingston presented, pursuant to the direction of an Act of Parliament—Customs Act 1901—Regulation dated 19th September, 1902.
- 3. Supply.—The House, according to Order, resolved itself into the Committee of Supply.

 Mr. Speaker resumed the Chair; Mr. Chanter reported that the Committee had agreed to certain resolutions.
 - Sir George Turner moved, That the Standing Orders be suspended, in order to allow the Report to be adopted at once, and to enable the Appropriation Bills for 1901-2 and 1902-3 to be respectively passed through all their stages without delay.

Debate ensued.

Question—put and resolved in the affirmative.

On the motion of Sir George Turner the House ordered that the Report be considered this day.

6. Ways and Means.-Mr. Chanter reported from the Committee of Ways and Means certain resolutions, which were read, and are as follow:-

Resolved—That towards making good the Supply granted to His Majesty for the services of the year ending 30th June, 1902, a sum not exceeding Fifty-two thousand four hundred and ninety-seven pounds be granted out of the Consolidated Revenue Fund.

Resolved—That towards making good the Supply granted to His Majesty for the services of the year ending 30th June, 1903, a sum not exceeding Two million six hundred and twentyone thousand one hundred and ninety-seven pounds be granted out of the Consolidated Revenue Fund.

Resolved—That towards making good the Supply granted to His Majesty for Additions, New Works, and Buildings for the year ending 30th June, 1903, a sum not exceeding Four hundred and six thousand and ninety-two pounds be granted out of the Consolidated Revenue Fund.

And the said resolutions were adopted by the House.

Ordered—That Sir George Turner and Mr. Deakin do prepare and bring in Bills to carry out the foregoing resolutions.

7. APPROPRIATION BILL 1901-2.—Sir George Turner then brought up a Bill intituled "A Bill for an Act to grant and apply out of the Consolidated Revenue Fund the sum of Fifty-two thousand four hundred and ninety-seven pounds to the service of the year ending the thirtieth day of June One thousand nine hundred and two, and to appropriate the Supplies granted for such year in this Session of Parliament," and moved, That it be now read a first time.

Question—put and resolved in the affirmative.—Bill read a first time. Sir George Turner moved, That the Bill be now read a second time.

Mr. Speaker resumed the Chair; Mr. Chanter reported that the Committee had gone through the Bill and agreed to the same without amendment.

12. Electoral Bill—Senate's Message No. 57.—The Order of the Day for the consideration in Committee of the whole House of the Senate's Message No. 57 having been read—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Chanter took the Chair as Deputy Speaker; Mr. Salmon reported that the Committee had resolved that the amendments made by the House, to which the Senate still disagrees, be not now insisted on, viz.:-

SCHEDULE OF THE AMENDMENTS MADE BY THE HOUSE OF REPRESENTATIVES TO WHICH THE SENATE STILL DISAGREES.

No. 21.—Page 4, clause 22, lines 34 and 35, omit "both Houses of Parliament" and insert "the House of Representatives."

No. 22.—Page 4, clause 23, line 38, omit "both Houses of Parliament pass" and insert "the House of Representatives passes."

No. 23.—Page 4, clause 24, line 43, omit "either House of Parliament" and insert "the House of Representatives."

No. 24.—Page 4, clause 24, at end of clause add "in accordance with the requirements of any such resolution."

No. 114.—Page 21, clause 151, line 8, after "votes" omit the remainder of clause. No. 180.—Page 39, Form M, lines 15 and 16, omit "The elector must vote for the full number of candidates to be elected, but not for any greater number."

No. 192.—Page 42, Form Q, lines 15 and 16, omit "You must vote for the full number of candidates to be elected."

On the motion of Sir William Lyne the House adopted the Report.
