FRIDAY, 10TH OCTOBER, 1902.

1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.

2. PETITIONS.—Sir Langdon Bonython presented two Petitions from certain persons in reference to the proposed construction of certain conservation works for the purpose of diverting the waters of the River Murray to the detriment of navigation, and praying that the Government will take such steps as will safeguard the interests of the several States of the Commonwealth as provided by the Constitution.

3. MESSAGE FROM THE SENATE.—ELECTORAL BILL.—Mr. Speaker announced the receipt of the following Message from the Senate:—

9. MESSAGE FROM HIS EXCELLENCY THE ACTING GOVERNOR-GENERAL.—A Message was delivered by the Usher of the Senate—

MR. SPEAKER,

The Acting Governor-General desires this Honorable House to attend His Excellency immediately in the Senate (hamber.

Accordingly Mr. Speaker, with Members of the House, went to attend the Acting Governor-General, when His Excellency was pleased to give the Royal Assent to the following Bills, viz .:---

"An Act to grant and apply out of the Consolidated Revenue Fund the sum of Fifty-two thousand four hundred and ninety-seven pounds to the service of the year ending the thirtieth day of June One thousand nine hundred and two, and to appropriate the supplies granted for such year in this session of Parliament."

"An Act to grant and apply a sum out of the Consolidated Revenue Fund to the service of the year ending the thirtieth day of June One thousand nine hundred and three, and to appropriate the supplies granted for such year in this session of the Parliament."

"An Act to grant and apply a sum out of the Consolidated Revenue Fund to the service of the year ending the thirtieth day of June One thousand nine hundred and three for the purposes of Additions, New Works, and Buildings."

"An Act to regulate Parliamentary Elections."

"An Act relating to the Allowance to Members of each House of the Parliament of the Commonwealth."

"An Act to make temporary provision for enforcing claims against the Commonwealth."

After which His Excellency was pleased to make a Speech to both Houses of Parliament as follows:----

GENTLEMEN :

(1) I am pleased to be able to release you from the exceptionally long and arduous labours of your first session, happily distinguished by the passing of many measures of the highest importance. Prominent among these are the Acts which, without endangering the international relations of the Empire, and without hardship to the races affected, effectively secure the exclusion of those immigrants whose presence in Australia would have made difficult, if not impossible, the accomplishment of our national ideals.

(2) The Uniform Tariff of Australia establishes freedom of trade and intercourse throughout the Commonwealth, thus laying the foundation of a commercial and financial union under which in future years the interests of all the States will be indissolubly blended.

(3) The creation of a Federal Electoral System, the organization of the transferred departments and of the Public Service as a whole, are evidences of the zeal and judgment with which you have laboured.

GENTLEMEN OF THE HOUSE OF REPRESENTATIVES :

(4) I thank you in the name of His Majesty for the liberal supplies that you have voted.

GENTLEMEN OF THE SENATE AND OF THE HOUSE OF REPRESENTATIVES :

(5) The provision you have made for the service and execution of judicial process, for the recognition of State laws and records, and for the hearing of claims against the Commonwealth, will facilitate the administration of justice throughout Australia.

(6) The control of New Guinea and the initiation of closer relations with some groups of the Islands of the Pacific combine to mark an important epoch in the development of the external relations of the Commonwealth.

(7) I now declare this Parliament prorogued until 14th November, 1902.
